

**DRUG/ALCOHOL/NICOTINE TESTING POLICY**

~~Drug and alcohol~~ Drug, alcohol, and nicotine used by students is detrimental to the educational environment and poses a direct threat to the health, morals, and welfare of the student population. Further, ~~drug and alcohol~~ drug, alcohol, and nicotine used by those students who are participating in District extra-curricular activities poses a threat to the physical and mental safety of those students and the students with whom they are competing. As a result of observed and suspected use of ~~alcohol and drugs~~ drug, alcohol, and nicotine by District students, the Board believes that initial and random testing of student athletes, as well as testing of the general student population upon an articulation of individualized suspicion of ~~drug or alcohol~~ drug, alcohol, or nicotine use, is necessary for the protection of student safety and welfare. The Superintendent is to develop regulations consistent with this policy.

Students of this District who are suspected of using, possessing, or selling ~~illicit drugs or alcohol~~ illicit drugs, alcohol, or nicotine while within the jurisdiction of the District shall be subject to ~~illicit drugs or alcohol~~ illicit drugs, alcohol, or nicotine testing. A determination of suspected use, possession, or selling of ~~illicit drugs or alcohol~~ illicit drugs, alcohol, or nicotine shall be made by a qualified individual in a position of authority in relation to the student. Student athletes are required to complete an authorization form that allows the District to conduct ~~drug and alcohol~~ drug, alcohol, and nicotine screening prior to the commencement of athletic activities and on a random basis thereafter. Should a student decline to complete this form, that student will not be allowed to participate in interscholastic athletics until such time as the student's parent or guardian signs the authorization.

The District shall develop appropriate disciplinary policies in the event of a positive test. These policies shall be consistent with the District's disciplinary policies for possession or consumption of illicit substances or ~~drug and alcohol~~ drug, alcohol, and nicotine.

The District shall develop, or contract with a third party to develop, procedures for ~~drug and alcohol~~ drug, alcohol, and nicotine testing consistent with those procedures authorized by the Alaska Statutes. The District shall also develop procedures that ensure the confidentiality of student test results and shall require all persons having access to those results to abide by these procedures.

All students affected by this policy shall be given notice of the policy and of the testing regulations adopted by the District.
