**RESOLUTION APPOINTING ELECTION JUDGES
AND HEALTH CARE FACILITIES ELECTION JUDGES**

WHEREAS, the Board has called a special election to be held on Tuesday, April 8, 2025, for the purpose of electing one (1) member to fill a vacant seat on the School Board, the term of which shall expire on January 4, 2027; and

WHEREAS, pursuant to Minnesota Statutes, section 205A.10, subdivision 2, the Board must appoint election judges for each polling place in accordance with Minnesota Statutes, section 204B.21, subdivision 2; and

WHEREAS, the Board must appoint election judges to deliver absentee ballots to hospital patients and residents of health care facilities in accordance with Minnesota Statutes, section 203B.11, subdivision 1.

2. The election judges shall act as clerks of election, count the ballots cast and submit the results to the Board for canvass in the manner provided by law for School District elections.

3. The School District clerk shall designate election judges to serve in the precincts and polling places designated by the District and shall designate election judges to deliver absentee ballots to hospital patients and residents of health care facilities, according to law.

4. Pursuant to Minnesota Statutes, Section 204B.21, Subdivision 2, the Superintendent is hereby authorized and directed to appoint additional election judges, absentee ballot board members and individuals to deliver absentee ballots to hospital patients and residents of health care facilities within the 25 days before the School District's special election on April 8, 2025 upon the determination that such additional election judges, absentee ballot board members and individuals to deliver absentee ballots will be required.
