The Denton ISD Head Start Program agrees to provide the following support to the project at this site:

- Provide Nuby Pediatrics and Head Start parents with a Denton ISD Head Start Physical Exam packet.
- Provide a list of all students who will need physical exams to Nuby Pediatrics.
- Acquire information from Nuby Pediatrics regarding location and service hours and advertise by way of flyers, digital signage and email/phone blast.
- Ensure that parents are informed to transport and accompany their child to the clinic services.

Nuby Pediatrics will provide the following:

- Provide services at 1103 N Elm Street.
- Complete physical exams for Denton ISD Head Start students who lack a primary care provider.
- Complete physical exams for Denton ISD Head Start students at no cost.
- Services include the completion of the physical exam form including blood draw for the Hematocrit or hemoglobin and blood lead level.
- Share the results from Hematocrit and blood lead level tests according to the HIPPA guidelines.
- Nuby Pediatrics will exchange health information listed on the Denton ISD Head Start Consent for Release form.
- Any information deemed confidential and described in the MOU shall be kept confidential and shall not be shared unless all parties agree.

The purpose of this MOU is to define the responsibilities of TWU Dental Hygiene Clinic; the TWU Speech, Language and Hearing Clinic; and the Denton ISD Head Start Program.

The Denton ISD Head Start Program agrees to provide the following support to the project at this site:

- Procure forms from the TWU Clinics to give to parents to obtain student history prior to screening/exam.
- Provide TWU Dental Hygiene Clinic; the TWU Speech, Language and Hearing Clinic, and Head Start parents with a Denton ISD Head Start Dental Exam packet.
- Provide a list of all students who will need to register for the clinic services.
- Acquire information from TWU about the clinic services and advertise by way of flyers, digital signage and email/phone blast.
- Ensure that parents are informed to transport and accompany their child to the clinic services.

The Texas Woman's University Dental Hygiene Clinic and the TWU Speech, Language and Hearing Clinic will provide the following:

- Provide service at TWU Dental Hygiene Clinic, Room 102 in the Multipurpose Classroom and Laboratory (MCL) Building, located on the corner of Bell Avenue and College Street on the Denton TWU campus.
- Services will include: Dental Screening, Professional fluoride treatment and Hearing Screening
- Students at the TWU Dental Hygiene Clinic, and TWU Speech, Language and Hearing Clinic will be under the direct supervision of licensed health care professionals who will lead all services.
- Services will be at no cost to Denton ISD Head Start Students.
- Dates of clinic services will be agreed upon mutually between the TWU Dental Clinic, and Speech, Language and Hearing Clinic staff and Denton ISD Head Start Health and Social Service Specialists.
