Treasurer Report: Thompson reported that we received our final State Revenue Sharing

payment for 2024. The total amount received in 2024 was \$1,484,400.00,

which was \$4,133.00 less than the year before.

**Building Report:** Rizk said we had several mobile home inspections. We have four (4) new

builds in Pheasant Run. We had 13 sewer discharge inspections in March.

**Planning Report:** Thompson announced the Planning Commission had their regular meeting on

March 24, 2025. An amendment for a special land use was approved for the Senior Center to include a 30x40 accessory structure. Three (3) rezoning requests were postponed in February and brought back before the Planning Commission for 2304 W. Wilson Rd., 2160 W. Wilson Rd., and parcel 18-23-400-003. The rezoning request was approved, and the first readings will be before the board tonight. The next meeting will be April 28, 2025, at 5:30 PM.

**ZBA:** Johnson reported the Zoning Board of Appeals have not met since November.

**Library Report:** Thompson relayed the Library has had some building repairs. There were

heating repairs on the first level, they are waiting on elevator repairs, and Friends of the Library is paying for new carpet in the computer lab. The book

sale will be Saturday, May 3<sup>rd</sup> and Monday, May 5<sup>th</sup>. The next Library Board meeting is May 14<sup>th</sup> at 5:30PM.

- Senior Center Report: SThomas announced Wednesday, April 23, 2025, is the next meeting. \$330.00 has been raised from the craft room. The rummage sale has been scheduled for the first week in May. On April 15<sup>th</sup> there will be a special pasty luncheon at noon. The board approved to clean and wax the floors in the activity room and to clean all the windows. The board approved transferring all of the information from the old computer to the new computer. The board approved a concrete pad for the 30x40 pole barn.
- Fire Authority Report: Bryan announced an election of officers was held, the same officers as last year were unanimously voted in. The Fire Authority Agreement is in review. A cost recovery policy is also being reviewed. Station 1 is having part of the roof replaced. Internal and external cameras were approved for both stations. The Fire Authority received a \$2,500.00 grant from the 100Club to replace face shields for all the firefighter's helmets. 50 smoke alarms were installed in homes during March. Fire Calls were up in March, at 50 calls.
  - BDA Report: Director Maxwell reported the temporary parking solution at the Sports Complex are now in place. Guests can park on the west side of the complex, closest to Hurd Rd., or use the smaller, existing lot closest to the fields. AMI has assured us that we are first on the list for asphalt. The pickleball courts will be open after the parking lot at the sports complex is completed. The contractor is scheduled to install divider fencing between the courts, and an additional gate at the northeast corner before the courts open. The Spring Cleanup at Bridge Park is scheduled for Tuesday, May 13 from 10 am 2pm. Lunch will be provided. The BDA will be holding a special meeting tomorrow, April 15, 2025. We did not have a quorum for the last regularly scheduled April 09, 2025, meeting.
  - Parks and Rec: JThomas announced on Saturday, April 19, 2025, at 11AM, in the Clio Park there will be the annual Easter Egg Hunt by The Clio Lions, Bethany Church, and Parks and Rec. About 600 kids came last year. We have \$6,789.14.
- **Sports Complex Report:** JThomas said there was no meeting due to the president of the Sports Complex having a baby.
- Supervisor Report: Rizk introduced Ethan Edwards who is from Frankenmuth High School. Ethan is interested in going into government as a career path and is job shadowing Supervisor Rizk. Field Road chip seal problem from last year is still being addressed by Genesee County Road Commission. Flooding has been an issue due to recent rains. Two weeks ago, we had a problem with yard waste

pickup. The furnace in the Board Room went out. We will be sending out an RFP on it. We had water main breaks in the area recently that caused issues for the Township and Clio City. Vienna Township never had a boil water advisory.
