We are one house over the district line putting us in Smackover district by 73 meters (0.045 miles). We can throw a rock and hit the district line from our home.. I work in El Dorado and their dad works in Urbana even further away from Smackover, If the children ride the bus home after school no one would be home. Mom works 8am-5pm. She would possibly be putting her job in danger for being late because of drop offs and having to leave early for pickup. Dad works 9am-8pm sometimes later. Grandparents who are actively involved in their grandchildren's lives are business owners in El Dorado as well. Our daughter is going into 4th grade and has already spent 4 years of elementary in El Dorado and moving her would interrupt her schedule and relationships. Our son will be starting Kindergarten and will be able to attend the same school as his sister. Please consider allowing us to plead our case before the board. Attached are maps and locations along with a copy of the petition for transfer, pictures of Teagan and a letter of acceptance from the Superintendent Jim Tucker of El Dorado.
