Summary:	Pursuant to Texas Education Code (TEC) Sec. 44.0331(a)(5) and Subchapter F, Chapter 271, Local Government Code, school districts that enter into a purchasing contract valued at \$25,000 or more shall document any contract-related fee, including any management fee and the purpose of each fee under the contract. Furthermore, TEC Sec. 44.0331(b) requires the amount, purpose, and disposition of any fee described by Subsection (a) be presented in a written report and submitted annually in an open meeting of the district board of trustees. The written report must appear as an agenda item.
