LATE FEES/INDIVIDUAL TRIP CANCELLATION:

Any group payments made more than seven (7) days past the due dates above will be subject to a \$250 late fee. There are no late fees for individual online payments, but travelers delinquent by two monthly payments are subject to having their reservation cancelled by Perform America-TX, LLC. Any refunds for cancelled trips will follow the CANCELLATION SCHEDULE below. There is a \$50 reinstatement fee for any cancelled travelers wanting to re-register for the trip.
