#### IV. Public Comments:

Comments are limited to three minutes per speaker, except that non-English speakers requiring a translator are limited to six minutes. The presiding Board officer may modify or waive these time limits as appropriate. Public comment shall not be used for personal attacks by the speaker against District employees or students. Speakers who engage in personal attacks or use insulting, profane, threatening or abusive language during any Board meeting shall be ruled out of order by the presiding Board officer and may be escorted from the Board meeting room by District peace officers or security staff. Any concerns or complaints regarding individual District employees, students, or parents must be resolved via the appropriate complaint process, as stated in Board Policy BED (Local). Pursuant to section 551.042 of the Texas Government Code, no Board Member or Administrator may respond to a member of the public regarding an item

that is not listed on this agenda, unless such response is a recitation of District policy or a statement of specific factual information.

David Garcia – addressed the board regarding the naming of the LBJ Field House. He asked that the LBJ Field House be named after one of their UISD teachers, a man who was once his team mate, and who inspired many, especially students. He asked that the field house be named after Mike Medina and spoke of some of Mike Medina's accomplishments in life.

Julissa Garza – stated she is a parent, a tax payer and teacher at UISD. She spoke about the cost of living increase, the 14 million dollar deficit due to the inability to maintain attendance rate and enrollment, especially after covid. She proposed an idea of online learning for students at UISD to bring up enrollment. She added that some parents kept their children at home because they still fear for the health and safety of their children, after covid. She mentioned some school districts and charter schools have offered online synchronous learning and have improved their enrollment numbers. She stated UISD has the resources for online learning such as the mi-fi and chromebooks and the buses that can sustain wifi capability. She added that the revenue they would be looking at for 3,400 students is about 20 million dollars which would bring UISD out of the 14 million dollar deficit.

Luis de la Garza – stated he is the new TSTA president effective June 1st. He commented that the nation is facing runaway inflation and salaries have not been able to keep up with and as a result of that many employees of the district have been working second jobs to help make ends meet. He added that the morale of many employees is low. He mentioned that the district has mentioned there is not enough money to increase district salaries; however, the district is allowing money to purchase a plague to honor Carol Summers and while the contribution from Mr. Summers is significant, he believes that the contribution of the district workers is equally as essential as they provide exceptional services to the needs of students on a daily basis. He mentioned that the amount that is saved by refraining from purchasing the plaque can be used to help a worker's family that may be struggling to feed his/her family. He asked that UISD create a significant cost of living adjustment for all workers based on their pay scale. This cost of living adjustment is separate from the raise that workers need in order to help sustain themselves and their families. He asked the board to provide comparable raises to all employees to mitigate the rising cost of inflation. He mentioned he researched three school districts who share the same demographics as UISD and he found they have higher starting salaries. He added that UISD uses staffing agencies and it is not in the best interest of the district. He ended by saying he is in support to help improve the quality of life not only for the students of UISD but also for the workers who make up the lifeline of this great District.

Edna Olmeda – asked that as they plan for next school years budget that they consider the high cost of living and the high rate of inflation and to give them a substantial increase in pay to make a decent living. She shared some personal matters that happened to her in her personal life and medical issues affecting her

health. She asked the board for the district to start cutting down on other things so that they can give the staff and teachers the raise they deserve.

Clarissa Fraga – stated she was there to represent many individuals who were left baffled at the injustices they endured with the current TIA system that the district has in place. She added she is a second grade teacher not partaking in the allotment. She said she is simply there as the voice of those who fear speaking. She said evidence can be provided that many teachers were discriminated against using an opinionated based evaluation known as TTESS. She gave several examples of the unfairness of the evaluations.

Jocelyn Martinez – addressed the board regarding the student safety. She stated her son fell and fractured his radius and wrist which led to surgery. She was told at the campus that no other accidents had happened in their playground. Ms. Martinez also stated the playground has no shade or trees and nothing for students to play with. She added that a safe playground should be created for all students regardless of their age or grade level and hopes this issue can be resolved.

Valentin Ruiz – stated he was there to speak for all UISD employees who do not have a voice because of fear of retaliation, bullying, bad evaluations, being relocated to another campus and/or fired. He apologized to the superintendent for saying that he makes twice as much as the president because what he meant to say is that he makes twice the salary of our congressman who only makes \$150,000 and has many years experience as a congressman. He added that our superintendent currently makes \$300,000 plus, with no prior experience while our new city manager only makes \$250,000 with prior work experience. Mr. Ruiz said he was not there to attack the superintendent and only speaking the truth that they need to cut the fact that tax payers are suffering including UISD employees who are suffering from a 9% inflation rate from July 2022. He added that all UISD employees deserve a cost of living adjustment. Mr. Ruiz also requested that the UISD board do a hair follicle drug test to clear the name of the board member that got himself in trouble and stated this is sending a bad message to employees and taxpayers if they refuse. He ended by saying that taxpayers are so upset that they will vote them out.

Jose Ovando – stated he stands behind the teachers and said they do need a raise. He said he was there to speak on the issue of redistricting. He said the previous attorney had mentioned to him that the board acts as one and if one does something wrong then the wrong belongs to all the others. Mr. Ovando stated that in his opinion, this redistricting is a violation of the Voter Rights Act. He told the board they were taking away the power to vote from the one of the poorest communities in Texas and that is not integrity nor honor. He stated they were encompassing one street to favor one board member who self-admitted he committed voter fraud and there is a record of that and according to the Voter Rights Act there has to be full disclosure of data and proposed maps and he has not seen any data. Mr. Ovando also stated that he agrees that there has to be a drug test not

only for teachers but for everybody including board members. He challenged the board to take a drug test and said he would take one too.

Victor Vasquez – addressed the board regarding redistricting. He stated he was surprised that Mr. Aguilar would sponsor something that is not bad for him. He said the board needs a code of conduct because teachers have one and students have one so the board should have one also. He stated there are situations in the past where board members have been dating teachers or employees and there is no code of conduct for that. He added that somebody got a contract and nothing was done and also somebody got arrested and still sitting at the table and going to school functions. He repeated they need a code of conduct and a drug test to be an example for all the kids.

Sara Santos – addressed the board regarding mileage for homebound. She said homebound teachers are getting paid mileage only to get there and it should be back and forth, not just one way. Another issue she stated was retirement. She said there is a cap on local and state leave when people are going to retire. Some of those days are paid at 100%, some at 75% and some at 50% and the rest of the days you lose them because you can't donate them. Another issue she stated was with STEP Academy which was implemented for children who make a mistake can learn. She said kids are not learning while they are at STEP because the teachers there are not doing their teacher duties and only doing teacher aide duties because all they are doing is logging into their google classroom. They don't do grading or lesson plans and Ms. Santos asked why are they getting paid the same salary when they are not doing all the responsibilities and duties that a regular teacher does. Ms. Santos asked for changes to be made on these three issues.

A motion to approve the consent agenda items was made by Mr. Ramiro Veliz and seconded by Javier Montemayor.

Mr. Francisco Castillo asked for more information on the irrigation item under awards and bids. He asked why we need irrigation and landscaping services.

Ms. Cordy Jackson responded that part of this bid is to provide the actual shrubs and trees and also the district does not have enough irrigators. She clarified that this bid gives us the labor for irrigation and planting and it also gives us the actual shrub, tree.

Mr. Castillo asked if we went with the lowest bidder.

Ms. Jackson responded that is was awarded to both because they to by line item.

Mr. Castillo asked if Parent Square was the lowest bidder.

Ms. Jackson responded that it was a renewal and it was the highest ranked vendor not necessarily the lowest but that was the vendor that the committee selected based on the criteria that the department gave her when they did the solicitation.

Michelle Molina made a sub-motion to table item D.

Stephen Trautmann clarified that based on Ms. Molina's request, they can pull Item D from the consent agenda and act on the remaining items with the motion that is on the table and once it is approved then they can address Ms. Molina's item D. He clarified that the motion is to approve A-J with the removal of D.

Motion was unanimously approved.

Mr. Ramiro Veliz clarified that Ms. Molina's sub-motion is to table Item D for the next board meeting.

Mr. Javier Montemayor stated there had to be a future set date for the tabled item. The item was tabled for the next scheduled meeting.

Motion was seconded by Ms. Aliza Oliveros and was unanimously approved.

A motion was made by Javier Montemayor and seconded by Michelle Molina to approve the discretionary funds requests as presented.

Motion was unanimously approved.

A motion was made by Gilbert Aguilar and seconded by Michelle Molina to approve the board minutes as presented.

Motion was unanimously approved.

D. Discussion and possible action regarding resolution approving employee compensation for temporary emergency closure on May 4, 2023

David Canales addressed the board and stated that on May 4<sup>th</sup> we had a water problem at Juarez-Lincoln and had to dismiss employees early and this resolution will help compensate those employees.

A motion to approve the resolution was made by Javier Montemayor and seconded by Aliza F. Oliveros.

Motion was unanimously approved.

E. Discussion and possible action to approve Board travel for the months of May and June 2023

A motion to approve board travel was made by Aliza F. Oliveros and seconded with discussion by Francisco Castillo.

MichelleMolina asked to be excluded from the South Padre trip.

Francisco Castillo asked to be excluded as well.

Motion was unanimously approved.

F. Discussion and possible action regarding naming of LBJ High School Fieldhouse pursuant to Board Policy CW Local - Naming Facilities

A motion to approve was made by Javier Montemayor and seconded by Michelle Molina to approve the naming of LBJ High School Fieldhouse.

Gilbert Aguilar recommended they name the LBJ High School Fieldhouse in honor of Mike Medina.

Motion was unanimously approved.

G. Discussion and possible action regarding Trustee appointments, assignments, and delegations to external/internal committees and boards

A motion was made by Javier Montemayor to recall our appointed trustee Rick Rodriguez' from the Appraisal Board and set a Special Called Meeting for next week to recall the votes cast in favor of Mr. Rodriguez and recast them in favor of a candidate to be determined at the next meeting. Motion was seconded by Michelle Molina. Ms. Oliveros opened for discussion.

Francisco Castillo asked if they could amend the motion to include the Safety Committee Assignment.

Javier Montemayor stated that was not an assignment that they vote on.

Stephen Trautmann clarifed that the Safety Committee by statute requires the board president and another trustee and it was his understanding that Mr. Rodriguez was not on the Safety Committee.

Aliza F. Oliveros stated she was on the Safety Committee. Francisco Castillo was ok with that.

Michelle Molina asked who was on the Clean Air Coalition Committee. Aliza Oliveros replied she was on that committee and also Francisco Castillo and Javier Montemayor is the alternate.

Michelle Molina asked to remove Francisco Castillo from that committee to allow her to be on that committee.

Aliza F. Oliveros stated she would remove herself so Ms. Molina can be on the committee.

Stephen Trautmann clarified the amended motion is in addition to Mr. Montemayor's motion, to place Ms. Molina on the Clear Air Coalition and remove Aliza F. Oliveros. He asked for a second on that amended motion.

Gilbert Aguilar seconded that motion and asked for clarification on the resolution for the appraisal district.

Stephen Trautmann clarified that for the appraisal district there would have to be a subsequent meeting with a resolution to recall Mr. Rodriguez's votes and at that point if the resolution gets approved Mr. Rodrigues is no longer on the appraisal district and there would be a second resolution on a second agenda item to recast those votes for a new potential trustee to serve on the appraisal district committee.

Francisco Castillo clarified that the Clean Air Coalition can name four individuals. Ms. Oliveros stated she would stay on and add Michelle Molina.

Ramiro Veliz, III clarified they now have the original motion by Javier Montemayor and seconded by Michelle Molina.

Motion was approved by Francisco Castillo, Javier Montemayor, Aliza F. Oliveros, Ramiro Veliz, III, Michelle Molina, Gilbert Aguilar

Motion was opposed by Ricardo Rodriguez

Motion passed.

# VIII. Reconvened from Closed Session, the Board will take appropriate action on items, if necessary, as discussed in Closed Session

The board reconvened from closed session at 9:21 p.m.

A. Discussion and possible action regarding amendment to Mini-Billboard Marketing Agreement between Impacto Media, Inc. and United Independent School District

Stephen Trautmann stated the recommendation is to authorize legal counsel to propose a second amendment to the Mini-Billboard Agreement with Impacto Media, Inc. as discussed in closed session to convey said Second Amendment to the Mini-Billboard Agreement to Impacto Media as UISD's final offer with no further negotiations and to authorize the superintendent to execute this Second Amendment to the Mini-Billboard Agreement if accepted and executed by Impacto Media Inc.

Ramiro Veliz, III made a motion to approve and seconded by Gilbert Aguilar. Motion was approved by Javier Montemayor, Aliza F. Oliveros, Ramiro Veliz, III, Michelle Molina, Gilbert Aguilar.

Motion was opposed by Francisco Castillo.

Motion Passed.

B. Discussion and possible action regarding redistricting of District 1 and District 4 boundaries due to 2020 census

Jaime Garcia stated as discussed in closed session, they went over the constitutionality of the proposed boundary maps which met all the constitutional requirements and the standard deviation is within the 10 percent rule.

Javier Montemayor motioned to open for discussion and seconded by Aliza Olilveros. He asked if the portion that is being added back to district one was previously part of district one.

Jaime Garcia stated it was part of District 1 approved in 2022 and it was removed from district one on January 25, 2023. Some input was gathered and legalities were discussed in closed session for the proposal and explained some of the legalities regarding this proposal.

Aliza Oliveros stated that normally redistricting is once every 10 years and if this item is approved that would be 3 times in the past 2 years which is a lot. She stated for several reasons that she could not support this item.

Francisco Castillo asked if the Department of Justice reviews this maps. Jaime Garcia clarified that they do not because the racial make up of Laredo and Webb County is 97% hispanic and they review maps where there has been racial segregation.

Gilbert Aguilar made a motion to approve the redistricting of District 1 and District 4 boundaries due to 2020 census. Michelle Molina seconded the motion.

Motion was approved by Javier Montemayor, Ramiro Veliz, III, Michelle Molina, Gilbert Aguilar.

Motion was opposed by Francisco Castillo, Aliza F. Oliveros.

### Motion passed

C. Discussion and possible action with respect to providing authorization to legal counsel to present proposed resolutions for sale of specific tracts of land, to be considered by the Board of Trustees.

Kenneth Valls made a recommendation to allow counsel to return to the board with a resolution with respect to the sale of the Las Blancas property as discussed in closed session and to continue with the analysis of the other properties.

A motion to approve the recommendation from legal counsel was made by Aliza F. Oliveros and seconded by Michelle Molina. Motion was unanimously approved.

D. Discussion and possible action regarding Superintendent's annual evaluation

Stephen Trautmann stated the recommendation is to approve the superintendent's annual evaluation as discussed in closed session.

A motion to approve the recommendation from legal counsel was made by Aliza F. Oliveros and seconded by Michelle Molina. Motion was unanimously approved.

E. Discussion and possible action regarding the appointment of Principal at United South High School

David Gonzalez stated his recommendation for Principal of United South High School is Martha Alvarez.

### I. Roll Call, Establish Quorum, Call to Order

Meeting was called to order at <u>6:03 p.m.</u> by Ramiro Veliz, III.

Announcement by legal counsel regarding trustee Montemayor being delayed due to business.

### II. Pledge of Allegiance

Pledge of allegiance is recited.

#### III. Public Comments:

Guillermo "Memo" Castro: Mr. Castro speaks about a concern regarding new warehouse development in front of Muller Elementary school.

The board president reminds Mr. Castro and the audience that public comments are for items on the agenda and that they would welcome him at the next Regular Board meeting. Mr. Castro replies, asking them to stand up for the integrity of the board.

Dolores Medrano: Asks the board to take action regarding the FBI raid against UISD board member and asks the board specifically why they chose to award the contract. Ms. Medrano also expresses concern about the manner in which newly board member for District 1 was appointed, and asks the board if a board member needs to be replaced, that this action be in a controversial manner.

Alfonso "Poncho" Casso: Speaks in regards to the resolution requesting resignation of board member Ricardo "Rick" Rodriguez. He requests the names of those board members who voted for and even abstained from voting for this contract, be included in the resolution. Mr. Casso shared with the board that he requested the FBI look into this matter (and other) and claims this was an illegal contract and asks for transparency.

Hilario Cavazos: Expresses his support for superintendent Gonzalez and speaks about the issue with board member Ricardo "Rick" Rodriguez. "A board member is here to serve, not to make money", said Mr. Cavazos. Mr. Cavazos asks that board member Ricardo "Rick" Rodriguez be removed and thus bring dignity back to the United ISD board.

Elsa Jasso: Ms. Jasso expresses her concern about board member Ricardo "Rick" Rodriguez and ask that he be removed. She also does not agree with the appointment of the newest board member for District 1.

Victor M. Vazquez: Mr. Vazquez states that after the raid, the district should have come out and explain what was going on. He argues the matter that by taking action to abstain, that board member awarded the contract. Mr. Vazquez also makes claims of retaliation. "When someone speaks up something happens to that person." Lastly, he asks the board why the superintendent has been evaluated four to five times this year. "Who evaluates you" stated Mr. Vazquez.

Jose Ovando: "I told you so" begins Mr. Ovando, taunting the board. He goes on to say that by appointing a board member (after the passing of late Mr. Ricardo Molina), is illegal, unethical and immoral and that he feels they took away the right of the people to vote.

"There is nothing within this board's power that they can do to remove Mr. Rodriguez or any trustee.

- Luis De La Garza advocates for teacher support by a pay increase of 7% to
  mitigate rising inflation of cost of living and states that the result of rising
  inflation has caused many employees to seek secondary jobs to make ends meet.
  "As TSTA president, I am here to collaborate with district personnel and trustees
  to ensure that students and employees are successful in their academic and
  professional setting".
- Victor Vazquez speaks against the Homestead Exemption. Mr. Vazquez wants the district to look through other avenues and provides his view of examples.

Mr. Arthur also adds that this Road has only one entrance and exit

for approximately 500 homeowners and campus staff. Mr. Arthur invites a board member of the La Bota Ranch Homeowners Association to also speak on this issue and asks the UISD Board for a resolution addressing the matter.

Javier Montemayor, trustee District 5: "Please note that while the board has been steady and consistent in it's efforts to address the salaries and wages of our teachers and staff, we continue working together and make concerted efforts to attract and retain quality employees. I recognize and applaud the UISD staff in identifying and addressing our district's needs. However, as to the Homestead Exemption currently available to UISD residents, I ask the board to consider keeping it the same and not reducing it with the increased appraisal values on our homes inflation and the higher cost of living in general removing this exemption, could be detrimental to many households. Providing some property tax relief should be a priority for us. In addition, the district I serve, District 5 includes

some of the oldest homes in UISD and as such many retired residents that live on fixed incomes. These residents will be directly affected by the removal of this exemption but we have taken positive steps like reducing the district's tax rate. I cannot at this time support any item requesting the removal or decreasing the Homestead Exemption. I ask the board to table this matter and put it for July so that we may all be present, or in the alternative reject this proposition."

Mrs. Benavides ensures the board that residents over 65, the taxes are frozen. The board looks at the possibility of requesting a meeting to address this matter once the legislative session has reconvened and passed.

- Michelle Molina makes a motion to table this item and reconvene at a later date to allow the full board to be present to voice their opinions.

#### III. Public Comments

Jorge Mendoza: Mr. Mendoza addressed the board to speak about his concern with the increase of Local Homestead and asks the board to seek other avenues to make up for this increase. He says "everyone has a household budget and people are constrained to their low income". He supports teachers and employees but asks the board to look at other means. Mr. Mendoza wants the board to also focus on student safety and provides an example of his concern. Lastly Mr. Mendoza suggested that someone propose that board members should be allowed one or two terms and "not 20, 30 years" he said.

Jose Ovando: Speaks against Local Homestead Exemption.

Victor Vazquez: Speaks against the Local Homestead Exemption. Mr. Vazquez commende the Safety Department for adding the position of Lead School Psychologist.

Dolores Medrano: States her opposition to the Local Homestead Exemption. She recommends that administration take a 5% cut in salaries instead of the 5% increase to the Homestead. "If you need more money, do what the rest of us are doing, we are cutting our expenses, cutting our travel, we are working harder and working longer", says Ms. Medrano. She goes on to suggest that maybe the district needs to freeze salaries, freeze travel, cut 10% from every department, among other things.

Ivan Rodriguez: Speaks out against adjusting the Homestead Exemption. Says the district may be a bit too soft on department heads. "We are all going through hard times", says Mr. Rodriguez and reminds the board of their duty to the students and then the taxpayers. Mr. Rodriguez lastly encourages the board to look into ways for cutting back expenses.

Alfonso "Poncho" Casso: Speaks about the Homestead Exemption and legislation in relation to funding for districts and teachers. He also believes that the district needs to better inform the community regarding Homestead Exemptions and that the district should wait on the outcome of the legislative session.

Tom LaFluer: Secretary for La Bota Homeowners Association. Mr. LaFleur speaks out about new land development directly across Muller Elementary school. The area currently endures a traffic concern and portrayed scenarios of implications of building a new Warehouse directly across the street. Mr. LaFluer provided the board with documentation for a visual of the site. On behalf of the La Bota Ranch Homeowners Association, Mr. LaFluer asked the support of the district to stop the construction of such warehouse.

James Aurthur: Muller Elementary concern. Mr. Arthur echoes Mr. La Fluers concern and provides the board with additional information and possible different options of road access. He also informs the board that they are contacting the city and county to address their concerns and ask for their support as well to help solve this problem.

#### IV. Items for Individual Consideration

# A. Discussion and possible action to approve resolution adopting Local Homestead Exemption

 A motion is made, by Michelle Molina for discussion, seconded by Gilbert Aguilar and Francisco Castillo. Michelle Molina thanks the administration for bringing this item forward and states her stand on not increasing the Homestead Exemption.

Francisco Castillo also speaks on not approving a resolution to adopt a Local Homestead Exemption.

• Gilbert Aguilar makes a motion to table this item indefinitely and that the Homestead Exemption remain at 15%.

Javier Montemayor also speaks against the Homestead Exemption and says he represents a large amount of retired individuals living on fixed income and how it would be detrimental to taxpayers.

Aliza Oliveros, says she has been against this since this item was initially presented to her and she stands her ground against it and has no further comments.

Javier Montemayor brings up that administration came to board with numbers and this is an issue that needs to be discussed as other important matters are discussed. "We are talking about \$9 million dollars", he said.

The board continues discussion on Homestead Exemption. Mrs. Oliveros said she requested a campaign for the district to inform the public as to why the decision to reduce the Homestead Exemption. "I was simply told no!" said Mrs. Oliveros.

 Ramiro Veliz asks board member Aguilar to amend his motion to table. Motion made by Mr. Aguilar is to table item on Local Homestead Exemption and seconded by Aliza Oliveros.

Ms. Laida Benavides presents on the Local Homestead Exemption. She states that legislators met the day before to address this matter and that Tax relief is coming. The recommendation by administration is that no action is taken on this item.

Jaime Garcia, legal counsel for UISD clarifies for the record on the implication of tabeling an item indefinitely as opposed to tabling it to bring back in the near future. Other board members address their concerns to not bring back this item.

 Aliza Oliveros rescinds her second motion to table, and makes a submotion to have the board simply vote for or against. The submotion is seconded by Michelle Molina and the board approves unanimously. • A motion is now made to take a vote for or against the resolution, motion made by Aliza Oliveros, seconded by Michelle Molina:

Against: Francisco Castillo, Javier Montemayor, Aliza Oliveros, Ramiro Veliz, Michelle Molina, Gilbert Aguilar.

Non Oppose, motion passes. The resolution regarding Homestead Exemption does not pass.
