NCLB Grants

The following table provides a summary of revenues and expenditures as of 5/31/2018 for our NCLB Grants:

Through May expenditures represent 74.78% of the budget for Title I, 70.46% of the Title II budget, and 99.74% of the Title V budget had been expended. Overall, 75.16% of the total budget for the three grants has been expended through May 31, 2018.

FY 18 Title I & II Grant Update:

The FY 18 Title I & II grants have been reviewed in detail and summer expenditures estimated. Title I & II expenses are on target to come in slightly below budgeted figures. Any remaining FY 18 funds will be carried over to the FY 19 grant allocations.

FY 19 Title I & II Grant Update:

The FY 19 ESEA of 1965 As Amended (ESSA) Application was released on June 13, 2018

- Title I The ISBE estimated allocation for FY 19 is \$372,643.
 This is \$18,472 less than last years original projection and \$39,671 less than the actual FY 18 allocation of \$412,314.
- Title II The ISBE estimated allocation for FY 19 is \$50,259.
 This is \$9,693 less than last years original projection and \$9,467 less than the actual FY 18 allocation of \$59,952.
- Title IV The ISBE estimated allocation for FY 19 is \$29,402.
 This is \$12,804 more than last years original projection of \$16,598.
 For FY 18 the District opted to transfer 100% of the Title IV funds to Title II.
- The FY 19 estimated allocation for all 3 grants is \$452,304, a decrease of \$36,334.

The district has completed all ISBE pre-application requirements of:

- Grant Accountability and Transparency Act Internal Controls Questionnaire submitted on 4/25/18 and ISBE approved on 4/26/18
- U.S. federal government's System for Award Management (SAM) annual re-activation
- FY 19 Title I District Plan board approved on 5/21/18 and ISBE approved on 5/29/18

FY 18 Title V (Rural and Low Income) Grant Update:
