- As of December 18, 2013 we have brought in \$22,730.80 in Ala Carte Sales. We have spent \$11,304.98 showing a \$11,425.82 profit at this time.
- For November, we served a total of 7,174 breakfast meals vs 8,837 for last year and a total of 9,564 lunch meals vs 11,716 for last year at this time. We averaged 422 breakfast meals served per day and averaged 563 lunches being served per day.
- Cafeteria served Christmas Dinner on the 12 of December district-wide. We had a really good turn-out.
- Ludy has submitted her records for a Nutritional Analysis to the Education Service Center. This is done before the CRE review that will take place in February.
