

**RESOLUTION AUTHORIZING CERTIFICATE OF TAX LEVY**

WHEREAS, Article 17 of The Illinois School Code [105 ILCS 5/17-1 et seq.] authorizes the Board of Education, Crete-Monee Community Unit School District No. 201-U, Will County, State of Illinois, to levy taxes for various purposes:

NOW, THEREFORE, BE IT RESOVED BY THE BOARD OF EDUCATION, CRETE-MONEE COMMUNITY UNIT SCHOOL DISTRICT NO. 201-U, WILL COUNTY, STATE OF ILLINOIS AS FOLLOWS:

**Section 1:** The following amounts of money, as indicated below and on the Certificate of Tax Levy attached and made a part of this document, shall be raised by tax for the various purposes as in the Certificate of Tax Levy indicated for the ensuing year.

- a. The sum of \$50,000,000 to be levied as a special tax for Education purposes;
- b. The sum of \$8,500,000 to be levied as a special tax for Operations & Maintenance purposes;
- c. The sum of \$6,200,000 to be levied as a special tax for Transportation purposes;
- d. The sum of \$500,000 to be levied as a special tax for Working Cash purposes
- e. The sum of \$0 to be levied as a special tax for Illinois Municipal Retirement Fund purposes;
- f. The sum of \$0 to be levied as a special tax for Social Security purposes;
- g. The sum of \$200,000 to be levied as a special tax for Fire Prevention, Safety, Energy Conservation, Disables Access, Social Security, and/or Specified Repair purposes;
- h. The sum of \$8,000,000 to be levied as a special tax for Special Education purposes;

**Section 2:** The Superintendent, Chief School Business Official, and Treasurer are hereby authorized and directed to take any action necessary to file this levy with the County Clerk and to have the taxes specified herein extended.

**Section 3:** The President and Secretary are hereby authorized and directed to sign the Certificate and file or cause the same to be filed with the County Clerk of Will County, State of Illinois on or before the last Tuesday in December of 2024.

**Section 4:** This Resolution shall be in full force and effect upon its adoption.
