Background Information

The Board of Trustees previously approved a Construction Manager at Risk (CMAR) Agreement with Satterfield and Pontikes Construction (S&P) for the New Transportation Center. The board previously approved the first GMP amendment in 2021 for the early steel package. This is for the second GMP amendment (GMP #2), which includes the remaining scope of work for this new facility.

Fiscal Implications:

GMP#2 pricing is provided in the proposal which is in the supporting documents. Administration is working to negotiate a lower amount and will provide the final amount at the Regular Board meeting.
