- I. The Shirley School Board held a regular meeting on February 26, 2024 at 6:00 p.m. in the BoardRoom. A quorum was established with four members.Kristina Tomasino was not in attendance.
- II. The Pledge of Allegiance was recited.
- III. Superintendent Wiggins went over the goals for the 23-34 school year as listed on the agenda for this meeting. He stated that we are working hard on our goals.
- **IV.** Principals Ward and Clark presented their Distinguished Devil awards for students who go above and beyond.

- V. Chad Brown made a motion to accept the meeting minutes from the January 22, 2024 meeting. Sam Shull seconded the motion. The vote was 2-0. (Due to Callie Davidson and Corey Murray being absent at that meeting.
- VI. Chad Brown made a motion to accept the financial report as presented by Superintendent Wiggins. Corey Murray made a second. The vote was 4-0.
- VII. Superintendent Wiggins explained to the board that due to schools missing days due to inclement weather, districts were allowed to submit a waiver to the state department to change from a traditional calendar (178 days) to an alternate calendar (1,068 instructional hours). Superintendent Wiggins presented the updated 2023 Spring calendar. Callie Davidson made a motion to accept the updated 2023-2034 calendar. Chad Brown seconded the motion. The vote for the new calendar was 4-0.
- VIII. Superintendent Wiggins presented the board with the 2024-2025 school calendar for approval, based on the votes of all faculty. Callie Davidson made a motion to approve the calendar for the 2024-2025 school year with the start date of August 14, 2024. Corey Murray seconded the motion. Superintendent Wiggins also gave the board a resolution stating the start date for next year for signatures.
- IX. Superintendent Wiggins recommended approval of the board with a board to board transfer for a student to transfer from Shirley School District to Rural Special School District. Callie Davidson made the motion to approve the transfer. Corey Murray seconded the motion. The vote was 4-0.
