Item Name: CONSIDER APPROVAL OF RFP #08-2023SE FINE ARTS CONSULTANTS

Item Summary: The purpose of RFP #08-2023SE Fine Arts Consultants is to establish an approved list of consultants to provide services specific to the performing and visual arts programs.

This type of award is beneficial to the District as it allows campuses and departments a variety of vendors to select from, while ensuring that the District is compliant with purchasing regulations according to TEC 44.031 and EDGAR.

This solicitation requested proposals from qualified contractors experienced in providing Performing and Visual Arts (PVA) Instructional and Instructional Engagement Services. The vendors provide targeted instructional support, professional development, instructional engagement training and support, rehearsal hall support, and/or instructional engagement materials for Lamar CISD performing and visual arts programs.

This award will be designed as an annual contract with an additional one-year automatic renewal option.
