The Illinois Association of School Boards is planning for an in-person Joint Annual Conference this November in Chicago. IASB is optimistic that statewide mitigation policies will permit the return of larger events, such as the Annual Conference, while monitoring COVID-19 conditions. On May 14, the state moved into the Bridge Phase of the Restore Illinois reopening plan, with the governor stating his intention to fully reopen as soon as June 11 if COVID metrics remain steady and continue to decline.

Joint Annual Conference registration and housing will open on **Tuesday, June 8**. Registration fees will remain the same as the previous in-person Conference in 2019; \$499 for the three-day event plus a \$200 housing deposit to reserve lodging.

Staff will monitor state and local health conditions provided by the Illinois Department of Public Health and local health agencies, and notify members and attendees of any adaptations due to the pandemic.
