- SN Program auditor is still in the process of auditing all our federal & state programs for compliance.
- On 10/5/24 we will have 5 of our elementary schools entering Apple Desserts with the help of their assigned FoodCorps Members in the Apple & Chile Festival. Stay tuned to hear if we win this year, last year we had 4 entries and didn't place.
- PVHS Vending machine has consistently been serving approximately 75 students daily. The FHS machine is still not operational but a representative will be here from Venducation the week of 10/7/24.
- The Fresh Fruit and Vegetable program (FFVP) at all 10 of our elementary schools and 2 preschools. All 10 elementary schools will have the program 2 days a week and our 2 preschools once a week. Tentative start date is 10/8/2024.
- Hydroponic towers are being implemented in classrooms at the following school sites: Animas, Apache, Bluffview, Country Club, Central Kitchen, Esperanza, McCormick, McKinley, Mesa Verde, Northeast, Heights, Hermosa & RHS.
- A 4H club 6 week pilot program for middle schoolers will launch on 10/29 in partnership with Boys & Girls CLub of Farmington. Recruiting documents will be shared the week of 10/7/2024 with all of our middle school administrators.
- FoodCorps Service Members manned a booth at the 111th Navajo Nation Fair Youth Day on 10/3/24 and it was well received. They shared information with educators and parents alike regarding the benefits of a FoodCorps Partnership.
