Summary:	<p>The Junior High Gymnasium bleachers are the original bleachers from 1984. The bleachers were recommended for replacement on our yearly internal capital improvements requests.</p> <p>The bleachers have become and are increasing difficult to operate. The system is binding and the tracks are breaking. The tracks have been welded several times and now the repairs are not allowing the bleachers to retract fully. In addition, the current bleachers do not have hand rails, stairs and are not ADA compliant.</p> <p>The bleachers quotes are the same as those installed in the High School Old Gymnasium. Everyone has been more than satisfied with the operation of these bleachers.</p> <p>To meet procurement requirements, Bellville ISD will utilizing an inter-local contract through BuyBoard Contract #583-19.</p>
