Consider Approval of Contract to Perform Efficiency Audit

**Background:**

In the event that the Board of Trustees approves an Order to Call a November Voter Approval Tax Rate Election in August, an efficiency audit must be performed. The deadline to select an auditor for the efficiency audit is July 3, 2026. The Legislative Budget Board has established mandatory guidelines identifying the scope and areas of investigation of an efficiency audit. According to the guidelines, the purpose of the efficiency audit is to provide information to voters regarding a school district's fiscal management, efficiency, and utilization of resources before a VATRE. Weaver and Tidwell, the District's current external audit firm, has provided a proposal to perform these services in the amount of \$16,000. The audit will be completed within three months. The results will be posted on the district's website, and the board must hold an open meeting to discuss the results before a VATRE.
