### Description

Learning sessions are facilitated at the Region 10 Education Service Center or at geographically clustered locations (e.g., Summer Roadshows), participating LEAs may request *onsite* professional learning (i.e., daily rates may apply based on individualized requests).

### **ESC 10 Responsibilities:**

- Provide classroom teachers and instructional coaches professional learning for foundational early childhood training from the R10 library of professional development offerings
- Provide discounted onsite services (e.g., e.g., 20% discount for early childhood instructional coaching)

- Invoice LEAs for services provided, outlining detailed costs, services rendered, and applicable dates
- Retain or contract qualified personnel to provide services

**LEA Responsibilities:**

The LEA shall:

- Remit payment based on the fee schedule in order to maintain Early Childhood Support Practices membership
- Designate a contact person to receive program communication and updates
- Provide administrator designee for onsite hosted events
- Distribute information regarding professional learning and other services
