1.0 **GENERAL FUNCTIONS**

CALL TO ORDER/ROLL CALL/ESTABLISH QUORUM

At 6:03 p.m., President Lori Ann Garza called this meeting of the Robstown Independent School District Board of Trustees to order.

5.0 PUBLIC PARTICIPATION

There were no comments from the public.

5A ROBSTOWN ISD REQUEST FOR PUBLIC COMMENTS ON THE USE OF THE ELEMENTARY AND SECONDARY SCHOOL EMERGENCY RELIEF II (ESSER II) FUNDS

Dr. Jose Moreno presented the use of the Elementary and Secondary School Emergency Relief II (ESSER II) funds to the Board. He reported that the grant was authorized by the Coronavirus Response and Relief Supplemental Appropriations (CRRSA) Act of 2021, Section 313 Elementary and Secondary School Emergency Relief (ESSER II) Funds. The intent and purpose of the funding is to prevent, prepare for, or respond to the COVID-19 pandemic, including its impact on the social, emotional, mental health, and academic needs of students. A total of \$5.5 billion was appropriated to the State of Texas and the school district's allocation will be \$5,568,488. Because of the hold harmless a certain percentage, will be taken off the total designated to the school district. The grant period was from March 13, 2020 (Pre-award) through September 30, 2022. Also, he reviewed the program guidelines, the key changes from ESSER III, additional changes, district allocation, and things to keep in mind. The proposed expenditures included the following: 1) Retention Stipends in lieu of raise -\$500,000, 2) TEA Foundation School Program (FSP) – Supplant of \$4,300,000, 3) Food Service - \$250,000, 4) General Fund Salaries of \$1,851,828, and 5) Indirect Cost of \$766,660. ESSER II was a one-year funding only. The following are the next three steps that they need to take: 1) Submit application, 2) Post requirements on the school district's website, and 3) Post application and uses of fund plan no later than thirty days of receiving the ESSER II Notice of Grant Award.

6.0 PUBLIC HEARING FOR THE PURPOSE OF RECEIVING PUBLIC COMMENTS ON THE ADOPTION OF THE PROPOSED 2021-2022 BUDGET AND 2021-2022 TAX RATE

Dr. Jose Moreno announced that anybody from the public could ask any questions on the proposed 2021-2022 Budget and 2021-2022 Tax Rate. Mrs. Vanessa Riggs reported that when they work on the budget, they look at the enrollment and the tax rate.

The school district's actual ADA was 2089 last school year. She reviewed the enrollments for the last several school years, and the enrollment has been going down. The school district had a 2.58% increase on the certified property values for the 2021-2022 school years. The proposed budget included the \$72,226,759 in certified values, an M & O rate of \$1.0436, a total of \$6,380,288 in collections, and a total of \$16,782,691 in state aid. She reviewed the M & O and I & S tax rates for the past ten years, the current and proposed tax rate, and the tax effect on an average residence. They are evaluating the class sizes to see where reductions can be made through attrition, due to the ADA/enrollment raises are not being recommended at this time. The retention incentives will be funded from ESSER III over the next three years. The total debt service for the 2021-2022 was \$885,684,76. This school year, they saved \$548,000 by consolidating Ortiz Intermediate, and employees will receive \$2500 for the next three years as follows: \$1500 the beginning of the school year, \$400 in December, and \$600 at the end of the year out of the ESSER III grant and an additional \$1000 stipend for the 2021-2022 school year will be added from the ESSER II grant. The budget was reduced by \$90,000 by reducing the supplies accounts by 5%, employee travel and miscellaneous accounts were reduced by 10%, and travel funds will not be allowed to be moved to other account codes. She reviewed the campus allocations, department budgets, and other special requests. After the ESSER II adjustments, the school district will have a balanced budget. She presented three different tax rate scenarios; however, she recommended the following tax rate: \$1.0436 for M & O and \$.5200 for the I & S for a total of \$1.5636 tax rate for the 2021-2022 school year. This tax rate will effectively be raised by .1689% and will raise taxes for the M & O on a \$100,000 home by \$1.76. In the Food Service Fund, as of August 21, 2021, the expenses exceeded revenues by \$411,973.54. The school district is still waiting on a one-time payment of \$151,000 from TDA, the beginning fund balance was at \$219,065, the summer feeding program balance was at \$251,330, and they will be requesting a transfer in from the Summer Feeding Fund of \$200,000. There were no questions from the community.

7B SUPERINTENDENT UPDATES

Dr. Jose Moreno presented the board members with a list of daily enrollments by grade level. Ms. Kelsey Cook presented the enrollment initiatives through marketing to the Board. She reported that the school district held a Block Walk on June 27, 2021, a two-minute television commercial was presented on KIII Domingo Live on July 25, 2021, radio advertisements on Magic 104.9 on July 30, 2021, a television commercial package was delivered on August 9, 2021, Skylert Phone calls are made weekly, social media was done weekly, and postings on the school district's website are posted on a daily basis. Also, they are doing Geo-Targeting with a five-mile radius and banner video samples are also being put out.

7D ROBSTOWN ISD FOOD SERVICE UPDATE

Mr. Chris Teager, RISD Food Service Director, presented a brief presentation on the school district's food service to the Board. He reported that they had training for the managers and assistant managers on recipes and several other topics. They held a food tasting test at the Robstown Early College High School for students to taste different foods and a survey was sent out to the students. At the high school, they will be offering more homemade items for breakfast, which allows them the ability to serve a more exciting menu. They will have a menu planning class, a roving chef, promotions, more taste testing, and more surveys in the upcoming months.

TASB's response was the governors executive order appears to restrict this option with its broad prohibition on local mask requirements. The attorney general has sent a warning letter to all school districts identified ss having masks mandates, regardless of how the mandate was characterized. The school district's attorney stated that at this time, on the mask being a part of the dress code there was no way around it. Also, Dr. Moreno was happy to report that they had around 85% of the school district's employees and students wearing their mask. After discussion, Dr. Moreno recommended to call an emergency meeting to approve a resolution to mandate masks.

DISCUSS AND CONSIDER APPROVAL OF A RESOLUTION OF THE ROBSTOWN INDEPENDENT SCHOOL DISTRICT BOARD OF TRUSTEES MANDATING THE USE OF FACE MASKS IN DISTRICT FACILITIES AND BUSES

Dr. Jose Moreno asked the Board to approve a resolution of the Robstown ISD Board of Trustees mandating the use of face masks in district facilities and buses. He informed them that the school district has continued to do contact tracing, continued to provide rapid testing, and continues to monitor on a daily basis. They want to make sure that they continue to protect the health and safety of the school district's students and staff. He proposed approving a resolution, as a team of eight, to mandate masks for thirty days. The mask mandate will be from August 27, 2021, through September 27, 2021. At a future date, they will announce the requirements for sporting activities. He read the following sections from the resolution: "Whereas, the Federal Drug Administration (FDA) has not authorized COVID-19 vaccines for children under the age of 12; and Whereas, the Center for Disease Control and Prevention ("CDC") and the Texas Department of State Health Services ("DSHS") have identified at least four variants of the COVID-19 virus, of which the Delta variant has been determined to be two times more contagious, and causes a greater percentage of hospitalizations, when compared to the original virus. Whereas, based on the Board's substantial interest in protecting the health and safety of the district's students, staff, and community, as well as its interest in accomplishing the District's educational purpose, the Board seeks to adopt this Resolution in an effort to control and mitigate the spreading of COVID-19 and its variant." The resolution will exempt a child under two years old, a person that cannot wear a mask or cannot safely wear a mask as defined by the Americans with Disability Act, a person with a qualifying religious exemption as approved by the school district, and a person for whom wearing a mask would create

a risk to their workplace health, safety, or job duty as determined by solely by the school district. After discussion, Dr. Moreno recommended approving a resolution of the Robstown Independent School District Board of Trustees mandating the use of face masks in district facilities and buses for thirty days.
