The regular meeting of the Medford Board of Education was called to order by Ms. Berg, Chair, at 7:00 p.m. in the Media Center of the Medford School. Members present were Mr. Anhorn, Ms. Berg, Ms. Chambers, Ms. Jones, Ms. Winkels and Superintendent Ristau. Ms. Janke and Mr. Sutherland were absent.

Motion by Ms. Jones, second by Ms. Winkels, to approve the agenda with additions. Motion carried.

There was no public input or recognition.

Motion by Ms. Berg, second by Ms. Chambers, to approve the consent agenda as presented. Motion carried. Expense Reports carried 4-0-1 abstained.

i) Secondary Principal – Mr. Babcock reported on several items. Notable changes to the handbook included facemasks in the clothing policy, NHS status for significant discipline, and the teachers' services section. Updates were provided on SEL and Social Studies curriculum. Students will be split up alphabetically. An update was provided on teaching models for in person and distance being combined.

ii) Elementary Principal – Mr. Carlson reported on several items. A mask policy was also added to the handbook similar to the high school. An update was provided on Social Studies curriculum. The school year will be starting in person but there will be changes to lunch, recess, and special classes. Mr. Carlson emphasized student safety, the need to be flexible and working together.

iii) Athletic Director – Mr. Werk presented a fall sports update to the board. MSHSL task force had two options. Reduce and keep in fall or reduce and move to spring. They decided on the latter. For Medford the only fall sport to continue was boys and girls cross country. Cross country was able to secure a home conference meet. There is fall practices for all sports being played in the spring. Updates were presented on guidelines and regulations from MSHSL. If a school has to go to full distance learning, then sports can't be played.
