I. SUPERINTENDENT'S REPORT

Supt. O'Neill introduced the VHS Chamber Singers who performed three holiday songs for the Board and audience members.

I.A.1. VCS New Teachers

The building principals introduced their new teachers for the 2021-22 school year. A listing of new staff members is included in the packet.

I.B. Legislative Update

Supt. O'Neill stated the current county mask mandate ends on December 17, 2021. Parents should expect a communication regarding that issue before the holiday break.

Supt. O'Neill also addressed the issue that occurred at the VMS and VHS. A third party will investigate the incident and he asks the school community for their patience as the process unfolds.

Supt. O'Neill referred to the listing of important dates including upcoming holiday concerts.

II. REPORTS AND PUBLIC INQUIRY

II.A. Budget and Finance Report - Steve Goss

Asst. Supt. Goss presented the Budget Progress Report for November, 2021 showing total revenues of \$7,010,161; total expenditures of \$9,204,820 and deficiency of revenues over expenditures of \$(2,194,659).

II.B. Bond Update

Asst. Supt. Goss gave an update regarding Bid packages and construction contracts from Series 1, Release 3A, including mechanical upgrades at Indian Lake Elementary this upcoming summer. Delays in the supply chain may still be a problem and require a longer lead time when ordering.

DJ Kalee suggested we change the officers on the Board. Garrett Kaltenbach addressed the board with concerns regarding how to support the staff with the lack of subs. Gabby Yost addressed the board regarding problems with bullying she and her friends have endured. Shelley Hall shared her concerns regarding bullying and asked the Board how the findings will be communicated to the community. Dana Ames shared her thoughts regarding masks. Brynn Najdowski thanked the Board for keeping class sizes small and increasing staff when needed. She also stressed her support of parental choice for masks. John Eiler addressed the Board with COVID-19 concerns and shared his data with the Board. Kelly MacDonell addressed the Board on behalf of the teachers with concerns regarding subs and student safety.
