In-person learning: 92% of Unit #40 students are participating in In-person learning.

We are now in Phase IV. 50 spectators allowed in the gyms, outside of the team members; may use these 50 as home team only, so parents could not attend out of town games. Public can watch online. The District will not charge admission and will not have concessions. Pixelot cameras are set up. Want to try to set up EJHS ballgames online too. Home teams will live stream their own games.
