# 11. Workshop(s):

# 11.1 Student Services – Sage & Martin

Director Student Services Laura Sage and Public Health Specialist Coordinator Nick Maniaci from the Southwest Suburban Health Department presented information about proactive efforts to save lives through increased accessibility and training around the use of Narcan (naloxone), a medication that reverses opioid overdoses. The presentation focused on a growing collaboration between the school district and the Southwest Suburban Health Department. Key initiatives included staff and nurse training sessions, distribution of Narcan boxes, and discussions about stocking Narcan alongside AEDs in schools. The goal is to treat Narcan like other life-saving tools, such as EpiPens or CPR, with the emphasis on community-wide preparedness, not just student-focused intervention. Feedback from Board members emphasized expanding training to athletic staff, students, and community members, reducing stigma, and making access discreet and widespread. Additionally, Ms. Sage noted the District also completed a special education audit and successfully relocated its Community Transition Services program to Madison School.

District Safety Coordinator Marla Martin presented information on vape detector wands, dog sniffing, and Halo Smart Sensors, which are designed to deter vaping and improve safety in school bathrooms and hallways. These camera-free devices detect nicotine, THC (even when masked), aggression, occupancy, tampering, and air quality issues, sending real-time alerts directly to administrators. The system is intended to support prevention and early intervention rather than solely focusing on discipline, and it integrates with student education programs addressing vaping and wellness. The Board supports a balanced approach that combines this technology with vape detection wands and expanded educational efforts to address student vaping and safety in a comprehensive manner. However, the Board also expressed concerns regarding privacy, installation challenges, and the overall costs, including device purchase, installation, and ongoing subscriptions. Ms. Martin will compile additional information to address the Board's concerns.

### 11.2 Financial Stability & Efficiency – Norris

Assistant Superintendent Aaron Norris presented the proposed 2025-2026 budget and preliminary tax levy workshop #2. A key focus was the "transfer of service" (TOS) process, which lets districts increase revenue limits when taking over services, especially for special education. This is crucial as mid-year shifts in students with Individualized Education Programs (IEPs) drive unexpected staffing and budget needs. During the 2024-2025 school year, an unusually high number of students with IEPs transferred into the District, prompting additional hires and budget adjustments. Though the budget remains balanced overall, some non-reimbursed positions could cause a minor deficit. Capital projects continue, funded partly by referendum dollars, and food service funding remains stable. Tax levy increases depend on state aid and property values, with a (likely) moderate mill rate increase. Budget management remains complex due to varying district wealth and funding challenges.

The Board will take action on the proposed 2025-2026 budget and preliminary tax levy at the June 23 regular board meeting, with spending beginning July 1. A Public Hearing on the 2025-2026 budget will be held on September 8, as well as approval of preliminary budget and levy before final revenue limit adjustments at the regular board meeting on the same date. Approval and adoption of the final 2025-2026 budget with final revenue limit adjustments and set final 2025-2026 tax levy will take place at the October 27 regular board meeting.

#### 12. End of Recording/5 Minute Break
