# **Approval of Revisions to Policy EHBB (Local) Special Programs: Gifted and Talented Students-2**<sup>nd</sup> **Reading**

# **SUMMARY:**

This item requests approval of changes to Board Policy so the EXPO Program Handbook and Board policy are the same. The Gifted and Talented Program Handbook had a few discrepancies from Board policy. Some procedures have been revised in the handbook and some revisions have been made to the Board policy EHBB Local.
