RESOLUTION AND ORDER DESIGNATING TRUSTEE POSITIONS BY NUMBER AND PROVIDING FOR ELECTION OF TRUSTEES BY NUMBERED POSITION (PLACE)

WHEREAS, the Pecos-Barstow-Toyah Independent School District (the "District") is governed by a Board of Trustees (the "Board") elected at-large; and

WHEREAS, Texas Education Code § 11.058 authorizes the Board, by resolution adopted not later than the 60th day before a trustee election, to order that candidates for trustee be voted on and elected separately for numbered positions and designated on the official ballot by the position number for which they seek election; and

WHEREAS, Texas Education Code § 11.058 further requires the Board to number the trustee positions in the order in which the trustees' terms of office expire, not later than the 60th day before the date of the election; and

WHEREAS, the Board has determined that designating trustee positions by numbered place will promote clarity for voters and candidates and improve election administration;

NOW, THEREFORE, BE IT RESOLVED AND ORDERED by the Board of Trustees of the Pecos-Barstow-Toyah Independent School District that:

Section 1. Election by Numbered Position

Pursuant to Texas Education Code § 11.058(c), the Board hereby orders that all candidates for trustee shall be voted on and elected separately for numbered positions on the Board, and that all candidates shall be designated on the official ballot according to the number of the position for which they seek election ("Place" or "Position").

Section 2. Timeliness of Adoption

This Resolution is adopted on the 20th day of January, 2026, and is intended to apply beginning with the first trustee election for which this Resolution is adopted, not later than the 60th day before election day, as required by Texas Education Code § 11.058(d).

Section 3. Numbering of Trustee Positions

Pursuant to Texas Education Code § 11.058(e), the Board hereby numbers the seven (7) trustee positions in the order in which the current terms expire, as set forth in Exhibit A attached and incorporated into this Resolution.

Section 4. Administrative Implementation

The Superintendent and appropriate District officials are authorized and directed to take all actions necessary and convenient to implement this Resolution, including but not limited to:

1. Providing a copy of this Resolution and Exhibit A to the District's election administrator(s) and/or the appropriate county election officials for ballot programming and election administration;

2. Ensuring candidate filing materials and public notices clearly identify the numbered position/place; and
3. Taking any other action reasonably necessary to carry out the purpose and intent of this Resolution.

Section 5. Conforming Local Policy

The Board directs administration to bring forward for Board consideration conforming amendments to Board Policy BBB(LOCAL) to reflect the election of trustees at-large by numbered position and to specify the schedule on which the terms for each numbered place expire.

Section 6. Non-Rescindable Action

The Board acknowledges that once it orders an election by numbered position under Texas Education Code § 11.058, the action may not be rescinded.


Section 7. Severability

Section 8. Effective Date


This Resolution is effective immediately upon adoption.
