TITLE Approval of Bond-Related Projects

1) Approval of Qualified Select Bidders List Based on Responses to Request for Qualifications (RFQ) 12-0027

BACKGROUND:

Article Eleven of the Arizona Administrative Code, Section R7-2-1110 (A-J), defines the use of a qualified select bidders list which a school district may use to determine contractors who will receive a notice of competitive sealed bidding for a construction project. This process is a selection method for establishing a list of best-qualified prime contractors for a specific single project. The selection process is based upon listed evaluation criteria and conducted through a request for qualifications. Once the selection process is complete the qualified bidders, (prime contractors) are invited to submit competitive sealed bids based upon architectural & engineering plans and specifications.

The use of a qualified select bidders list is restricted to a specific project as identified in the request for qualifications. This project includes new construction and site renovation at Amphitheater High School as identified in the 2006 Blue Ribbon Budget Analysis and Facility Needs Committee Summary & Recommendations. The scope of work includes restroom upgrades for ADA compliance, remodeling of the 500 Wing and the construction of athletic facilities.

Eleven general contractors responded to the RFQ. The evaluation committee, five members, included a project designer, a contractor, a school district facilities representative and two additional members selected by the district.

RECOMMENDATION:

The Administration recommends that the Governing Board approve Diversified Design & Construction, Lloyd Construction Company, Core Construction, D.L. Withers Company and W.E. O'Niel as the five highest ranked Prime Contractors based on their response to Request for Qualifications (RFQ) 12-0027.

EVALUATION CRITERIA:

Responding contractors are to provide the following:

COMPANY QUALIFICATIONS: (40%)

- 1) any deficiency orders issued against the general contractor by the Arizona Registrar of Contractors within the last three years
- 2) any current unresolved bond claims against the prospective contractor
- 3) any judgments or liens against the proposed contractor within the past three years
- 4) current bonding availability and capacity
- 5) any filing with under the United States Bankruptcy Code, assignments for the benefit of creditors, or other measures taken against creditors in the past three years
- 6) current project workload
- 7) safety record and worker's compensation rate
- 8) contractors project team, key members, training & qualifications
- 9) contractors capabilities and qualifications to provide the scope of work required

RECENT PROJECTS: (40%)

Responding contractors to provide five recent examples their company's work similar to the scope to the work required, providing a description of each project not to exceed three pages, (per project) in length to include:

- 1) owner name and phone number
- 2) project superintendent name and resume
- 3) project construction schedule actual vs. projected
- 4) method of approach to include subcontractor selection plan
- 5) method of approach to include safety plan
- 6) project safety record
- 7) project location
- 8) description of construction challenges and how addressed

PROJECT MANAGER & CONSTRUCTION SUPERINTENDENT QUALIFICATIONS (20%)

The project manager & construction superintendent to be assigned, their qualifications to complete the required scope of work, their resume, time with the company, list of similar projects completed to include a description of the project, the location(s), the owner's name & phone number and the school principal's name & phone number.
