Chris Reitan - Commented on Julie Yates new staff orientation. Wonderful job. Thanked staff that attended. FY21 audit - expecting final report before November board meeting. He adds he is traveling until Sept 1.

#### b. CCSD ARPA 2021-2022 Mitigation and Prevention Plan

M/S: Steenstra/Nelson Scott Brookshire: We have a motion to approve CCSD ARPA 2021-2022 Mitigation and Prevention Plan.

#### Discussion :

Chris Reitan: This plan has already been board approved in June as a first draft. Board to consider page 8. Recommendation of removing and replacing the language regarding quarantine timing. Not allowed back on grounds until released from public health. Suggests removing old language related to the travel policies that were in place last spring. Alaska has removed the state mandated testing after travel. If we move forward and the board doesn't do anything as presented, those changes would take place based on the motion. There was no consensus about mask wearing. A solid split amongst the committee about masking. Option 1 is the CDC guidelines for masking. Option 2 is to honor parent choice. If neither option is chosen, then masks wearing would continue same as last year.

Scott Brookshire - Let's ignore option 1 and 2 for now and discuss main body of document.

Daniel Nelson - Doesn't think option 1 or 2 are fitting options. Doesn't like either option. Doesn't like wording.

Tristan Douville - States we have a policy that states we prevent unsafe work environments.

Chris Reitan - States doctor documents would be needed in that policy. Chris Reitan noted on option 2 bullet 1 - public health cannot do more that recommend.

Scott Brookshire - Motion to amend to change option 2 to read:

In consultation with state and local public health representatives, CCSD strongly recommends that students, staff, and all school visitors follow the CDC guidance of universal indoor masking in all school facilities during school hours. However, CCSD also recognizes individual Employees have the right of "mask choice." Parent(s)/guardian(s) also have the right of "mask choice" as it pertains to their children while in school. CCSD will encourage staff, students, and all school visitors follow the suggested CDC guidelines, but will respect individual rights and decisions regarding "mask choice." Once a parent, guardian, or student has expressed or demonstrated a preference concerning masking, CCSD employees are to refrain from attempts to change the student's choice.

Mask Choice does not apply in the following circumstances:

- Mandated mask wearing as recommended by Public Health Representatives.
- CCSD mitigation plans for athletics or special events/activities requiring mask wearing.

To allow for transparency, CCSD highly recommends "mask choice" be carefully considered given the current Public Health "Close Contact Tracing Process" as detailed on page 7-8 of the CCSD ARPA Mitigation and Prevention Plan

Motion seconded by Daniel Nelson.

A deeper discussion ensues amongst board.

Amendment carries on a 3 to 2 vote.

Original motion: Voting for approval of CCSD ARPA 2021-2022 Mitigation and Prevention Plan as amended. Motion carries on a 3 to 2 vote.

VOICE VOTE: 3 for 2 against. MOTION CARRIES: 3 to 2 vote.
