I. SUPERINTENDENT'S REPORT

A. Recognitions

- 1. National School Lunch Week October 9-13 "Barnyard Fun Click, Clack, Moooo School Lunch is for Youuu!" Maureen Ouvry: Mrs. Ouvry shared the fun theme for National School Lunch Week.
- 2. National Principals' Month Charles Glaes: Principals were recognized for all they do for the students, district, and community.
- 3. National School Safety Week October 15-21 Steve Fryling: Mr. Fryling shared the new CrisisGo app that is being tested for use with all staff in the event of a crisis.
- B. October 4, 2017 Count Figures: Supt. Glaes stated that enrollment is down 21, which is better than the projected enrollment figure used for budgeting.
- C. Legislative/Election Update: Legislative update included information on At-Risk funding Section 311, CTE equipment upgrades, and Enhancement Millage changes. Mr. Glaes also reviewed the District's Operating Millage renewal which is on the November 7 ballot.
- D. Important Dates: Supt. Glaes referred Trustees to the listing of important dates in their packet. The District received a thank you from a Portage Public Schools' band parent in appreciation of the well-organized Vicksburg Marching Band Festival. Sixteen bands will be competing at Vicksburg for the MSBO Marching Festival.
