## **OPENING OF MEETING**

A moment of silence was observed. The pledge of allegiance and pledge to the Texas Flag were led by Wessendorff Middle School student Daniel Chavez.

Mrs. Danziger attended the LEAF New Staff Stampede dinner and Convocation. She also went to the Terrell Elementary School soft opening and visited several campuses.

Mr. Lambert visited campuses and went to a midnight football practice at Randle High School.

Mr. Welch went to the Wright Junior High School 6th grade orientation event and attended Convocation. He also visited Terrell Elementary School.

Mrs. Bronsell attended the soft opening of Terrell Elementary School. She also thanked the Lamar CISD police department, neighboring police departments and the Lamar CISD staff for their help with the start of school.

## SUPERINTENDENT REPORT

Dr. Nivens shared comments about the start of school and recognized the Transportation Department for addressing the issues that occurred.

### **PUBLIC HEARING**

Ms. Bronsell opened the public hearing on the budget and proposed tax rate for the 2023-2024 fiscal year at 6:55 p.m.

Ms. Jill Ludwig presented information on the budget and proposed tax rate for the 2023-2024 fiscal year.

Ms. Box asked if the cost of opening a new school is included in bond funds. Ms. Ludwig said some funds are included, but most of the cost is for construction.

Mr. Welch asked why the tax rate is lower if we are growing. Ms. Ludwig explained the set growth percentage the State uses.

Mr. Welch asked what the current total bond debt is. Ms. Ludwig said it is \$2.834 billion.

Dr. Nivens clarified the difference between opening a school and building a school and the funding that can be used for each.

Ms. Bronsell closed the public hearing on the budget and proposed tax rate for the 2023-2024 fiscal year at 7:14 p.m.

Mrs. Danziger asked if the District has to pay additional funds for football games that will be played at stadiums outside the District. Mr. Gabbard said the affected schools are working with the District to help with the associated costs and Lamar CISD is working with other entities to streamline the financial impact.

Mr. Welch asked when the District anticipates going out for another bond referendum. Dr. Nivens said it would be Spring 2025.

Mrs. Hotzel asked about the price of the turf replacement. Mr. Buchanan explained the cost of artificial grass turf compared to the cost of the turf and substrate.

Mrs. Hotzel asked if the District is moving forward on replacing the turf at Traylor Stadium or waiting to see if the Bond passes. Mr. Buchanan said the District is working with vendors to get the purchase order completed now so the vendors can begin producing the turf and then amend the purchase order, if necessary, if the bond passes.

Dr. Nivens stated that the Athletics Department and the Maintenance and Operations Department will be monitoring the foundation and bleachers to ensure both are safe for students and spectators.

Mrs. Box asked if the bond could be separated so the public can vote on each item individually. Dr. Nivens said that is a decision that the Board can make.

Mrs. Bronsell stated that the agenda item would be tabled so that the Board can discuss it with the attorney during Closed Session.
