COVID UPDATES

Superintendent Lutz provided an update on COVID and the present learning models. We are in the same learning model since we started school. What we are doing in school is working. To date there are no cases of community spread in our schools.

COVID numbers in our county are rising. Superintendent Lutz provided an update on the number of district staff and students who are in quarantine. Our COVID support team says we can continue to stay in our current model.

District leadership will meet on November 17th with health professionals regarding the current situation. With cold weather, hunting, and holidays coming up we want to be prepared for an outbreak. We have contingency plans in place.

Superintendent Lutz indicated if we go to a more restrictive learning model it is harder to come back to a less restrictive model because we lose an important data point – how we are doing in our district.

Joel Roberts and Abigail Enquist reported on Bemidji High School activities including: the current learning model, homecoming, and the cancellation of winter formal.

Referendum Summary - Next Steps

Superintendent Lutz thanked everyone who voted in the referendum. It was rejected and our budget issues remain unresolved. The district leadership and school board will need to look for ways to stabilize the budget with cuts. We are looking at \$4 million - \$6 million in cuts next year and the following year. No action was taken.
