Mr. Dugan,

After our discussion these last two days, we have decided to move forward with an appeal of Midland School District's decision to deny our school choice request to keep our daughter, Naomi, at Bald Knob School District. We, her parents, believe that it is in Naomi's best educational, social, and psychological well-being to keep her at Bald Knob School District. To move her to Midland would be a hardship not only on Naomi but also on the family as a whole. Here are some of reasons for keeping Naomi at Bald Knob:

1. Proximity to work

- a. Bald Knob is <u>28 miles</u> from ASU-Beebe where I teach full time. From my office to Midland elementary is <u>53 miles</u>. My work schedule allows me to pick up Naomi in Bald Knob, but I physically could not make it to Midland in time for school pickup. There also would not be anyone at our house to meet her if she has to use school transportation from Midland.
- b. Bald Knob (H. L. Lubker Elementary) is 13 miles from my husband's office in Augusta, AR. Midland Elementary is 39 miles from his office. He takes Naomi to school every day and Midland Elementary is in the opposite direction from his work as well as mine.

2. Proximity to sibling daycare/activities

- a. Our son, John River, goes to preschool in Searcy, AR which is significantly closer to Bald Knob than Floral (Midland elementary). This has allowed me flexibility in pick up for both of my children.
- b. Naomi attends extracurricular activities in Searcy, AR. These are only possible because I can pick her up in Bald Knob and make it to Searcy in time for these classes and pick up my son.

3. Continuity of education and environment

a. Naomi attended kindergarten at Bald Knob (H. L. Lubker) this past year and had a wonderful experience. She excelled academically and formed close friendships with teachers and classmates. She would be distraught to no longer have her closest friends as classmates. We feel that the Bald Knob school district will continue to help her grow academically and socially.

Spending time with my children is the most important thing to me. Keeping her at the Bald Knob School district allows more time together as a family, the continuation of pre-existing schedules/activities, and is the most reasonable option logistically for our family.

Dear Commissioner Key and Members of the State Board of Education:

On July 7, 2021, I received a letter from Bald Knob Superintendent Melissa Gipson notifying me of Naomi Gordon's acceptance as a school choice transfer student. I called Ms. Gipson's office and spoke with Christy Soles because no paperwork related to this student had been submitted to the Midland District prior to May 1, 2021. Ms. Soles informed me that the application was received by Bald Knob on April 21, 2021 and was faxed to us on April 29, 2021. We did not receive a fax from Bald Knob on that day. I am unable to determine whether a fax completed transmission status sheet is available from Bald Knob to show that the fax was actually transmitted. Upon inspection of the application, there is no time/date stamp from the nonresident district that is required by Rule 2-3.02 showing that the application met the deadline of May 1, 2021. There is a written notation.

On July 12, 2021, I received an email from Ms. Soles with the attached application. On that same day, I mailed a letter to the parent, Ms. Meredith Gordon informing her that her application on behalf of her child, Naomi, had been rejected because the District was at its 3% limitation cap for allowable transfers.

On July 15, 2021, I received an email from Ms. Soles containing a Petition for Legal Transfer on behalf of Naomi Gordon. The petition was considered by the Midland Board of Education at its legally held meeting on July 15, 2021. The Board voted to reject the petition. On July 16, 2021, I sent a letter to Ms. Gordon informing her of the decision. On July 19, 2021, I sent an email to Ms. Soles informing her of the decision.

On July 20, 2021, I received an email from Taylor Dugan, ADE Attorney Specialist, informing me of the appeal that causes this response to be written.

First, the Midland District would offer that the application was not appropriately received by the May 1, 2021 deadline.

If, however, the Board determines that it was, the Midland School District continues to plead with the State Board of Education to honor the 3% limitation cap for allow transfers that is

placed in the law to help school districts deal with the loss of students that might be caused by the provisions of the School Choice Act.

It is my understanding that Ms. Gordon has recently built a home in the Midland School District. The District does not understand why a person would choose to build a home in the District and then not want to send their children here. The building of a home is a very important part of life and surely the selection of a school district would play a part in that decision. Additionally, all of the convenience factors laid out by Ms. Gordon in her appeals letter were known facts when she decided to make her residency within the District. In general, parents of students in our District travel in many different directions for their employment and are in similar situations to the appellant, but they choose to place their children in our District.

In Ms. Gordon's first argument, the District would be able to provide bus transportation for Naomi, and if her mother is able to pick her up in Bald Knob at pick up time, then Naomi would be arriving at home about the same time as her mother considering the amount of time she would be on the bus and the additional commuting time from Bald Knob to her home that Ms. Gordon would have to do.

In Ms. Gordon's second argument, the Pre-K which is now located at Pleasant Plains would be closer to her home than the Pre-K in Searcy.

Finally addressing Ms. Gordon's third argument, I find young children to be much more resilient about change than adults. Moving from one school to another is the norm for many children who go on to perform at acceptable levels academically. Friends and teachers constantly change. I'm sure that the Midland District, where the Gordons reside, can provide a more than acceptable environment for Naomi's growth academically and socially.




