The Facilities/Construction Dept. committee has reviewed all proposals received for *CSP 2010-069*, *Cherish Center at United 9th Grade Campus – Demolition Package*, and based on their qualifications and best value offered to the District, the committee recommends that this project be awarded to the highest-ranked bidder, Leyendecker Construction, Inc., in the final negotiated amount of \$241,500.

The original bid amount was \$266,000, a second negotiated bid amount was submitted in the amount of \$244,500.00, and a suggested reduction of an additional \$3,000.00 credit for deleting the relocation of three trees is also recommended by the Administration, resulting in a final bid amount of **\$241,500.00**.
