Changes and supports for DAEP students

- No longer using E20-20 for secondary core academics. Students receive work and instruction from their
 campus core academic teachers while at DAEP. Principals have reported that this has been a good
 change and teachers are seeing results in students when they return from DAEP
- Mentoring, Character Education lessons, and transition support for DAEP students
- Tiered Behavior System
- Ongoing campus check-ins with students in DAEP
- Increase in communication processes between DAEP, campuses, and Administration

- Substance Use Treatment Counseling for Students who failed Extra-Curricular participation drug tests
