- 1. Call Meeting to Order: Chairman Lau called the board meeting to order at 7:09 pm with Trustee Erickson and Trustee Barker in attendance. Vice-Chair Torgesen and Trustee Stoor would separately join the meeting already in progress. Also in attendance were Clerk Jonathan Balls, District Secretary Dawn Beeton, Principal Jess McMurray, and Principal Debra Daniels. Superintendent Stein had previously asked to be excused from the meeting.
 - **1.1. Approval of Agenda:** Chairman Lau asked if there were any additional agenda items to be added to the posted agenda. Chairman Lau asked that the New Business agenda item to be moved up to after the Input agenda item. With no further changes brought forth to the posted agenda, Trustee Erickson made a motion to approve the agenda as amended. The motion was seconded by Trustee Barker. By a voice vote, the motion passed unanimously.
 - **1.2. Pledge of Allegiance:** Chairman Lau invited the trustees and administration to join Clerk Balls in saying the Pledge of Allegiance.

Trustee Stoor entered the meeting.

- 2. Reopen 2019-2020 School Budget: Chairman Lau noted that the 2019-2020 School Budget is now reopened.
- 3. Continuous Improvement Plan / Administrative Reports:
 - **3.1. Chairman:** Chairman Lau commented to the board that he, Trustee Stoor, and Superintendent Stein met with Representative Gibbs and Senator Harris to discuss the needs of the district prior to the upcoming legislative session.

Vice-Chair Torgesen entered the meeting.

3.2. Superintendent: Principal Daniels reported to the board regarding the new See Tell Now app the schools are using. She also updated the board regarding the Threat Assessment Team training, and the

attendance at the National Safety Conference. Clerk Balls mentioned the maintenance items being completed in the district as well as that PERSI has notified all school districts that they do not have to pay into the sick bank for the next 18 months. Clerk Balls commented that this will be proximately a \$75,000 savings to the district after the 18 months.

- **3.3.2.** Tigert Middle School: Debra Daniels mentioned that they had 48 TMS students in the recent band and choir concert.

5. New Business:

5.1. 2020-2021 Calendar Process Discussion: The board had a discussion regarding setting the 2020-2021 calendar. Forming a committee was discussed as well as who was going to start the process. The boarded decided to let the Principals start the process with Principal McMurray creating the initial first draft. Chairman Lau asked that the board see the first draft at the January board meeting.

7. Tigert Middle School Construction

7.1. Approve December Construction Bills: The board reviewed the bills to be paid in December 2019 for the Tigert Middle School construction totaling \$28,467.63. After a few questions and subsequent discussion, Trustee Erickson made a motion to approve the Tigert Middle School construction bills to be paid in December 2019. Trustee Barker seconded the motion. Using a voice vote, the motion passed unanimously.

8. Old Business

- **8.1. Proposed 2019-2020 School Budget Revision:** Clerk Balls reviewed the proposed changes to the 2019-2020 budget due to the Emergency Levy, increased state literacy funds, and small changes that have happened since the initial budget was set last June. The board asked questions and discussed the changes.
- **8.2.** 2020-2021 Supplemental Levy Resolution: The board discussed the supplemental levy amount and the term. The carry forward, emergency levy, and impact to the property owners were discussed. After the discussion, Trustee Erickson made a motion to call for a resolution asking the voters of the school district to authorize a one-year supplemental levy in the amount of \$698,000. The motion was seconded by Vice-Chair Torgesen. Using a voice vote, the motion passed unanimously.
