BACKGROUND AND SIGNIFICANT ISSUES: On November 20, 2014 the Region One Education Service Center Child Nutrition Program – South Texas Cooperative (CNP-STC) acting on behalf of its members, obtained seven (7) proposals for Food Service Uniforms & Marketing Items Proposal 15-10-03. On December 16, 2014 the Region One ESC Board of Directors met and approved seven (7) vendors for award; effective January 1, 2015 through December 31, 2016 with the option to extend up to two (2) additional one-year periods if all parties are in agreement. This proposal allows CNP-STC members to purchase uniforms and marketing items related to School Nutrition Programs. This includes, but is not limited to: shirts, pants, aprons, caps, name tags, pencils, pens, plaques, embroidery, silk-screening, menu board systems, signage systems, and customized packaging.

On behalf of the CNP-STC membership, the current awarded vendors were offered the opportunity to extend their proposal for an additional one (1) year period; the term of this extension is effective January 1, 2017 through December 31, 2017, with the option to extend the contract one (1) additional one-year period if all parties are in agreement. Six (6) vendors agreed to the extension option, except one (1) company: *Solice Technologies Powered by Echo Eight, Inc. - Brownsville, TX*, they did not submit the required extension agreement and vendor certifications/affidavits, despite multiple attempts to contact them.

**RELATED GOAL:** To assist Child Nutrition Program – South Texas Cooperative members in Region One and other school districts, charter schools, and governmental entities throughout the State operate more efficiently and economically (TEC §8.002).

**COST AND FUNDING SOURCES:** Cooperative members order products and services directly through the awarded vendor(s); there is no cost to the Region One Education Service Center. A cost recovery fee is paid by members to join the CNP-STC.
