Request for Applications RGV FOCUS CCMR Enhancement Grant Application Deadline: Wednesday, May 8, 2024

Overview

RGV FOCUS, an initiative of Educate Texas, works through the tenets of collective impact to improve educational outcomes across the Rio Grande Valley. Our vision is for all RGV learners to achieve a degree or credential that leads to a meaningful career. Over the past year, RGV FOCUS has been leading an RGV College, Career, and Military Readiness Professional Learning Community (CCMR PLC), through which district professionals across the Valley are able to meet, collaborate, and share best practices towards improving CCMR opportunities for their students, as well as increasing Texas House Bill 3 Outcomes Bonus Funding for their districts.

Educate Texas is inviting current RGV CCMR PLC participants to submit an application under the RGV FOCUS CCMR Enhancement Grant program to support CCMR efforts in RGV districts. Funds awarded under this request for applications are to be used strategically to improve CCMR strategy and opportunities.

The goals of the RGV FOCUS CCMR Enhancement Grant program include:

- Build capacity for district and campus staff to work collaboratively to improve CCMR outcomes.
- Strategically expand CCMR access and opportunities for students in RGV school districts.
- Utilize data to drive equitable access to CCMR opportunities.
- Encourage peer-learning opportunities among RGV CCMR PLC participants.

The RGV FOCUS CCMR Enhancement Grant program aligns to the <u>Educate Texas 2025 Strategic Plan</u>, specifically the goal to contribute 85,000 new higher education degrees and certificates to the Texas Higher Education Coordinating Board's "Building A Talent-Strong Texas" goal by 2025, primarily focusing on African American, Latino, and economically-disadvantaged students.

Use of Grant Funds

RGV FOCUS CCMR PLC districts must adhere to the following guidelines when developing their grant application.

Allowable Costs:

- Grant funds may be used for materials, supplies, travel, outreach, and other necessary costs for program development or enhancement.
- Grant funds should cover expenses in a gap area; grant funds should not supplant current funding.
- Grant funds should directly impact district CCMR strategy or outcomes.

Required Activity for Grant:

Grantees must convene a district CCMR Leadership or Steering Committee, including district/campus
administrators, counselors, CTE staff, and instructional staff to align existing CCMR work, identify CCMR
goals, monitor CCMR progress, and collaborate to identify barriers and troubleshoot solutions. Funding
for convening(s) can be included in grant budget. Convening(s) must occur during the grant period.

Disbursement of Grant Funds

Educate Texas will disburse grant funds in one equal payment to grantees according to the requirement and approximate date below.

- Present data and/or best practices at an RGV CCMR PLC session during the 2024-2025 school year.
- Commit to convening District CCMR Leadership/Steering Committee. Identify CCMR goals; track and report local data to advance CCMR goals.
- Submit progress report on or by January 31, 2025; submit final project report on or by June 30, 2025.

The CCMR Connect project emphasizes increasing college enrollment rates, especially among at-risk students and those from low socioeconomic backgrounds in the Brownsville Independent School District. With 87.7% of students facing economic disadvantages and 72% considered at-risk, our targeted efforts are crucial. Recent data indicates that only 28% of 2023 graduates met TSI ELAR and Math criteria, and just 18% met AP criteria.

In response, we have planned CCMR Student Connect and CCMR Community Connect events across all six comprehensive high schools to discuss the benefits of PTECH/ECHS and Advanced Placement (AP) programs. The CCMR Student Connect events will provide middle school students and counselors with orientation sessions during school hours, focusing on higher education readiness and support systems.

Meanwhile, the CCMR Community Connect events will gather parents, higher education representatives, and industry partners to tackle college enrollment barriers and enhance educational equity. These events will also feature military recruiters and JROTC departments to present on military service opportunities and preparation initiatives.

Our third initiative, CCMR Industry Connect, will enable students and staff to collaborate with Workforce Solutions Cameron and local industry leaders to examine job market trends and regional career pathways. These interactions, including visits to our facilities and student-led panels, will focus on salaries, certifications, and degrees in high-demand fields. Through advisory boards and curriculum development sessions, we aim to refine our instruction and prepare students for high-demand, well-paying regional careers.

Local CCMR Tracker Summary:

• This provides monthly data on key college readiness metrics such as the percentage of students meeting TSI (Texas Success Initiative) ELAR and Math criteria, and AP (Advanced Placement) enrollment. The district uses this data to assess college and career readiness among student subpopulations and identify areas for improvement. Monthly campus meetings between counselors and administration are held to review this progress data and create action plans to meet campus targets.

Local PEIMS Reports:

 These reports offer official demographic and academic accountability records, helping to inform the district about progress toward CCMR outcomes and validate data from the local CCMR tracker.

TAPR Report:

Provides summative demographic and academic performance data, which is used to set district goals.

 Provides access to student success reports, so district leaders can identify trends and make decisions about higher education.

CMCR Connect Engagement Data:

 Includes data related to student and family engagement in proposed CCMR events, such as attendance rates and feedback from surveys or focus groups. This information provides insights into the effectiveness of outreach efforts and the level of community involvement.

The CCMR Leadership/Steering Committee is structured to ensure effective coordination, communication, and decision-making for the CCMR Connect project. Comprising key stakeholders—including CTE and curriculum administrators, campus leaders, counselors, teachers, industry partners, and student representatives from all six comprehensive high schools—the committee aims to drive the success of the initiative.

Meeting Schedule and Agenda:

Monthly Meetings: To discuss project timelines, stakeholder responsibilities, and progress.

Agenda Items:

- Goal Setting: Establish measurable goals and benchmarks to track progress and evaluate the impact
 of interventions.
- Calendar Review: Finalize the schedule for CCMR Connect events, aligning with school calendars and facility availability.
- Data Review: Analyze CCMR outcome data, including AP and dual enrollment figures, persistence rates, industry certifications, TSIA testing results, and event feedback.
- Action Planning: Develop and review strategies to address challenges, improve outcomes, and ensure equitable access to CCMR opportunities.
- Reflection: Assess the effectiveness of initiatives, discuss lessons learned, and identify areas for improvement.
- Planning Next Steps: Outline future actions to keep the project on track and integrate insights from past meetings.

Through regular engagement and data-driven decision-making, the committee will guide the implementation, monitoring, and continuous improvement of the CCMR Connect project, fostering equitable access to college, career, and military readiness opportunities for all district students.
