## I. SUPERINTENDENT'S REPORT

## A. Legislative Update

Supt. O'Neill shared that no budget has been set at this time. The state Senate heard testimony on the "Return to School" Plan, this bill package is more accurately described as a proposal for virtual learning. The US Senate GOP introduced the HEALS Act. Overall for education, the introduced bill includes \$105 billion, however, for K-12 education, only \$70 billion would go toward schools.

#### II. Return to School Plans

Supt. O'Neill discussed the current draft of the VCS Return to School Plan. He stressed that this document is a draft and input was still be solicited from parents/teachers. If the district does not feel schools can be opened safely or if there are PPE concerns, VCS would certainly not open for face to face instruction on August 31<sup>st</sup>.

Due to the storms and power outages. A motion to adjourn for 15 minutes (until 7:30 p.m.) was made by Forsyth and supported by Emmert.

## III. REPORTS AND PUBLIC INQUIRY

#### A. Financial Report - Steve Goss

- 1. Budget Progress Report for Month Ending July 31, 2020 Asst. Supt. Goss presented the budget progress report for July 2020, showing total revenues of \$88,729; total expenditures of \$539,571 and deficiency of revenues over expenditures of \$(450,842).
- 2. Replacement of the VMS fire alarm system

Asst. Supt. Goss presented the proposal for Hi-Tech Electric Co. to replace the VMS fire alarm system at a total cost of \$150,000.

Asst. Supt. Goss also gave an update of summer bond projects including the roofing projects that have wrapped up for the summer. The model classrooms in the school buildings are in progress and looking great. Updates to the tennis courts will be done before the start of the school year.

Asst. Supt. Goss answered questions from the board regarding state aid and the state of the budget for 2021.
