Mr. Eddie Zuñiga addressed the board and presented the results of the overview by the state of the Schools FIRST (Financial Integrity Rating System of Texas). He stated there are four different ratings that the district can receive. They are: Superior Achievement, Above Standard Achievement, Standard Achievement and Substandard Achievement. He explained that there are 20 indicators that the state looks at when rating the district. The first six are Critical Indicators and if the district answers no to any of these six indicators it's an automatic Substandard Achievement rating. Mr. Zuniga announced that UISD has received Superior Achievement for the 10th straight year and continued to explain the twenty indicators. The information presented by Mr. Zuñiga is included as part of the minutes.
