1. Summary of changes to the existing school safety plans and drill plans as recommended at the Annual Review meeting(s):

- A. During the 2024-2025 school year, all seven campuses conducted all required safety drills, and that documentation was submitted to the ROE on April 13, 2025.
- B. The district began implementing year 1 of the District Improvement Plan, specifically, these items are related to safety:
  - By September 30, 2024 RCS will begin implementation of at least quarterly building perimeter checks.
    - Quarters 1-3 have been completed. Officer Kraft will conduct Quarter 4 this week
    - PA/PreK exterior door numbers
  - By December 1, 2024 RCS will update the existing Emergency Operations Plan (EOP).
    - This was completed and copies shared with all schools and first responders.
  - By January 31, 2025, the district will have a comprehensive emergency reunification plan in place.
    - District is prepared for the reunification plan as outlined in the EOP–Standard Response Protocol.
    - Discuss implementation of reunification drill.
      - July/August drill with Admin/Clericals .
        - After July 29th (Kraft is [REDACTED])
        - 190 Day secretaries return August 1st.
      - When to practice with all staff?
- C. Implementation of Raptor.
  - Moved from Navigate360 to Raptor which aligns with the Standard Response Protocol.
  - SRP posted in all classrooms in all schools. (Buildings, if you need more copies, contact Tom Magers)
  - Do we need some more training for admin? Sounds like yes.
- D. Open Discussion
  - Intercom system status update. PreK does not have one yet. When their clocks arrive...PA/PK will be a separate dial code.
