#### **Recommendations for Hire**

There were no recommendations for hire from Superintendent Paula Renken.

The board asked Administrator Alma Gutierrez if she had any recommendations for hire Alma Gutierrez recommended teacher Margarita Sepulveda for 1<sup>st</sup> grade Reading/Social Studies, and teacher Jennifer Baggett for  $2^{rd}$  grade Reading/Social Studies.

A motion was made by Mark Frerich to hire elementary teachers Margarita Sepulveda and Jennifer Baggett as recommended by administrator Alma Gutierrez. Dan Laws seconded

Paula Renken asked that the record reflect her belief what the board is doing is illegal and I will pursue legal action with our council and TEA.

Tony Ashley, also want it noted that President John Paul Schuster contacted Walsh Anderson to clarify this particular situation and Walsh Anderson did confer with him and state in this specific situation as long as the board carried it unanimously that it could be done.
