

RESOLUTION abating a portion of the tax heretofore levied for the year 2025 to pay debt service on the General Obligation Refunding School Bonds, Series 2015B, of School District Number 33, DuPage County, Illinois.

WHEREAS, the Board of Education (the “*Board*”) of School District Number 33, DuPage County, Illinois (the “*District*”), by resolution adopted on the 5th day of February, 2015 (the “*Bond Resolution*”), did provide for the issue of General Obligation Refunding School Bonds, Series 2015B (the “*Bonds*”), and the levy of a direct annual tax sufficient to pay debt service on the Bonds; and

WHEREAS, on the 27th day of February, 2015, a duly certified copy of the Bond Resolution was filed in the office of the County Clerk of DuPage County, Illinois (the “*County Clerk*”); and

WHEREAS, the Bond Resolution established a Refunding Bond and Interest Sinking Fund Account of 2015 of the District (the “*Bond Fund*”) from which principal and interest on the General Obligation Refunding School Bonds, Series 2015A (the “*2015A Bonds*”) and the Bonds is paid; and

WHEREAS, the 2015A Bonds have been refunded and that portion of the taxes levied in the Bond Resolution to pay the 2015A Bonds have been abated; and

WHEREAS, the Board has determined and does hereby determine that funds are available in the Operations and Maintenance Fund of the District (the “*O&M Fund*”) in the amount of \$400,000 to pay a portion of the debt service on the 2015B Bonds (the “*O&M Available Funds*”) and that it is necessary and in the best interests of the District that the O&M Available Funds be transferred from the O&M Fund to the Bond Fund; and

WHEREAS, the Board has further determined and does hereby further determine that it is necessary and in the best interests of the District that the District abate a portion of the tax

heretofore levied for the year 2025 to pay the principal of and interest on the Bonds by the amount of the O&M Available Funds:

Now, THEREFORE, Be It and It is Hereby Resolved by the Board of Education of School District Number 33, DuPage County, as follows:

Section 1. Incorporation of Preambles. The Board hereby finds that all of the recitals contained in the preambles to this Resolution are full, true and correct and does incorporate them into this Resolution by this reference.

Section 2. Transfer from O&M Fund to Bond Fund. In accordance with the rules and regulations of the Illinois State Board of Education and specifically Section 100.50(d)(1) of Title 23 of the Illinois Administrative Code, the School Treasurer of the District is hereby authorized and directed to transfer the O&M Available Funds from the O&M Fund to the Bond Fund on the date hereof.

Section 3. Abatement of Tax. The tax heretofore levied for the year 2025 in the Bond Resolution shall be abated by the amount of the O&M Available Funds, as more particularly described as follows:

Section 4. Filing of Resolution. Forthwith upon the adoption of this Resolution, the Secretary of the Board shall file a certified copy hereof with the County Clerk, and it shall be the duty of the County Clerk to abate said tax levied for the year 2025 in accordance with the provisions hereof.

Section 5. Severability. If any section, paragraph, clause or provision of this Resolution shall be held to be invalid or unenforceable for any reason, the invalidity or unenforceability of

such section, paragraph, clause or provision shall not affect any of the remaining provisions of this Resolution.

Section 6. Effective Date. This Resolution shall be in full force and effect forthwith upon its adoption.
