**Washington, Cheri Wysong** - Stated that Mrs Schmitz had an awesome attendance with 99.43%. Been through Testing. They are also starting classroom interventions for those that need just a bit more. The focus for August and September is Empathy. There is evidence on testing results that show summer slide.

**Lincoln, Adam Metzger** - Stated that enrollment numbers have went up by a couple kids. 96.7% for attendance at this time which is awesome. MAP testing is completed and it went well. McKinney Vento training was completed and it was very informative. Because of this training we were able to identify a couple more students and get them the resources they need. We have 1 new staff member. Parent teacher conferences are coming up very soon. The bookfair was a great success and went on last week. The Sharing is Caring program started and a few food bags have already been requested. Arrival and dismissal surveys went out.

Jr High, Lisa Mayhall - Stated that the enrollment numbers are pretty consistent. Open house was last month and they had a great turnout. The Panther Den has already been active and helping out. Student Council has a fundraiser going on. Digital Creations is a new class and they are learning to make posters and will be helping with the yearbook. Every Monday is Movement Monday and all classes do some type of activity during class to get up and move. There is a Lunch and Learn program going now during lunch for those that need extra help. Science and Math have a new textbook series as well. MAP Testing finished up at the end of August and there was visible growth. There were gains in most areas. Matt Wilhelm will be a guest speaker (through the PEF) at the Jr High and Lincoln. High School, Kevin McDonald - We have been able to make contact with all Ghost Students. Many are enrolled or in homeschool. Homecoming week has wrapped up and went very well. ASVAB testing. The military does this testing at no cost and it helps with post high school planning. Moving forward this will only be given to Sophomores. All clubs are in full swing. MAP testing was completed and the 10th graders in Math 68% are on or at grade level. ELA has also seen gains. This is a huge bump. Open House was August 24th. Parent Teacher conference letters have went out as well.

#### **Building and Transportation**
