- d. ADOS 2 Follow-up: MVSEC will purchase the follow-up videos and schedule two sessions for around February. Payment will be in MV carryover. Start the series again in September for those who didn't attend this year or for new psychologists and SLPs.

- **a.** HB 3070: Amends the School Code. Provides that school guidance counselors, teachers, school social workers, and other school personnel who work with pupils in grades 7 through 12 shall be trained to identify the warning signs of mental illness and suicidal behavior (instead of just suicidal behavior). **To be enacted January 1, 2014.**
- b. Scott Carchedi, the new ND SW, presented a proposal for a grant to be submitted in January from the American Psychiatric Foundation to inservice school staff on the warning signs and options available for students with mental illness. The grant includes materials, ppts, etc
- c. Each director will think about nominating a couple of licensed staff members from their district to be trainers and to participate in this grant.
