- The Board will not allow the introduction of new information or materials related to agenda items once the agenda is posted.
- The Board's discussion of any agenda item will not exceed 14 minutes, with each Trustee allowed two minutes to comment.
 However, the Board President, at his or her discretion, may extend the amount of time that each Trustee is allowed to speak, but must ensure that each Trustee is allowed an equal amount of time.
- The Board will review and amend its operating procedures annually.

Board's Constraints for the Superintendent

The Board places the following constraints on the Superintendent

- The Superintendent shall not allow low performing campuses to have inequitable access to resources.
- The Superintendent shall not allow schools to be unsafe.
