Action item to approve the proposal submitted by Tandem Cyber for Managed Security Service Provider (vCISO & Cybersecurity).

**Recommendation:**

To select and approve the proposal submitted by Tandem Cyber to provide Managed Security Services (vCISO & 24/7 Cybersecurity) to WCJC.

**Background and Rationale:**

Following the Board's approval in May to initiate a Request for Proposal (RFP) process for a new Managed Security Service Provider (MSSP), we received twenty-one proposals from qualified service providers. Each submission offered a range of capabilities including vCISO services, 24/7 cybersecurity operations including incident response, and ongoing risk management. The evaluation process was rigorous, using detailed assessment criteria including technical expertise, experience and qualifications, service approach, compliance & regulatory experience, reference and track record, and pricing structure.

After a comprehensive review process, Tandem Cyber was unanimously selected as the recommended provider (attached is the evaluation sheet). Tandem demonstrated exceptional strength in strategic cybersecurity leadership, operational maturity, and 24/7 threat monitoring and response. Their approach to integrating with our internal team, proven track record in higher education, flexibility engagement model, and competitive pricing make them the optimal choice to advance our cybersecurity maturity.

Based on this evaluation, we are requesting formal Board approval to proceed with contracting Tandem Cyber as our new MSSP providing both vCISO services and continuous security operations.
