Request for Proposals for Architectural/ Engineering Services Browning Public School District No. 9

Browning Public School District No. 9 ("District") is requesting proposals for Miscellaneous Food Service projects. The services under this request include design, plan production and construction documents; bidding coordination and evaluation; and construction administration to include, but not limited to: shop drawing review, pay request approvals, change order production, site inspection and coordination with School District Facilities Committee.

The funding for these services may consist in whole or in part of federal education funds received under 20 U.S.C. §§ 7701 et seq. and, in accordance with the requirements of 25 U.S.C. § 450e, the procurement of these architectural/ engineering services will be subject to a **PREFERENCE for qualified Indian organizations or Indian-owned economic enterprises** as more fully set forth in the solicitation materials available from the District.

Additionally, this project may be in whole or in part funded by pending bond approval, as such the District reserves the right to cancel any or all of this project.

Responding firms should send five (5) copies of their written proposal to Browning Public Schools, P.O. Box 610, Browning, Montana 59417, Attention: Corrina Guardipee-Hall, Superintendent. **Proposals must be received no later than 4:00 pm on Friday, October 8, 2021.** All proposals must contain the requested information and be plainly marked "Architectural/ Engineering Services Proposal." No faxed proposals will be accepted.

All proposals must contain the following information:

1. Statement of qualifications to perform the requested services.
2. Experience and qualifications of personnel assigned to this proposed project.
3. A brief listing of 10 related projects completed for Browning Public Schools and other Montana school systems.
4. Names, addresses and phone numbers of five references.
5. Proof of professional liability insurance, general liability insurance, and the limits of those policies.
6. Detailed description of the firm's approach to these projects and the firm's ability to complete the work within the time outlined in the scope of work.

The District may select a firm from submitted proposals or select their highest rated firms for additional interviews.
