AWARD OF THE BID

- A. An "Intent to Award" notification will be emailed by January 9, 2026. The final award requires the approval of the Board of Trustees.
- B. We expect the bid to be awarded on or around Friday, February 20, 2026 following the Board of Trustees regular meeting of the previous day. The successful bidder will be contacted by 3:00 PM on Friday, February 20, 2026.
- C. The contract will be awarded to the lowest responsive and responsible bidder, or bidders, as determined by the NCSD. Determining the lowest responsive and responsible bidder the NCSD will judge on the basis of price, conformance to specifications, and bidder's qualifications as authorized pursuant to NRS 332.075 and 332.085.
- D. The NCSD may accept any portion of the total bid offer.
- E. The NCSD reserves the right to reject any and all bids and to waive informalities and minor irregularities in the bids received.
- F. The NCSD reserves the right to award any bid on an all or none basis in the best interest of the NCSD.
- G. Upon award of the contract the successful bidder shall execute an acceptance of the award in a form acceptable to the NCSD which shall state that the bidder agrees to be bound by all bid documents. All deliveries made during the term shall be made subject to the terms of all of the bid documents.
- H. Invoices issued pursuant to this contract by the bidder will be processed for payment as each order is delivered; provided it is invoiced correctly with all required supporting documentation. Invoices will be presented to the District Office within forty-five (45) days of the delivery.
- I. Any discrepancies between the specification information furnished on the bid and the bidder's product being offered must be documented. No bidder will be allowed to change any specification after the bid is opened.
- J. The bidder shall be solely responsible for complying with all laws, including but limited to, codes, statutes, regulations, rules, and ordinances of the county, state and federal governments.
