Elementary/Secondary Summer PD 2019

#### **Brief Overview:**

During the week of June 3-7, we provided professional development for our MCSD teachers in the following areas: CPM/Math, Science, ELA/Writing, Wonders. The professional development provided was based on building administrator recommendations and the needs assessment survey sent out to all certificated staff in the spring. All teachers were notified by the end of February that training would be available to them the first week of June. Each teacher that participated in content specific training, earned a daily stipend of \$150.00.

**Wonders (Elementary Reading Program)**- 1 day of training- # of participants 10 Elementary Instructional Coaches and principals met with Marybeth Flachbart and Rosie Santana from Education Northwest. The team reviewing the implementation of the Wonders reading program. Areas of weakness in the program were discussed as well as areas of needed additional support. The team created plans for PD centered around literacy and Wonders program, as well as areas to maintain consistency in the district. For the 2019-2020 school year, the elementary team, with the support of the literacy co-op will focus on collective efficacy and building leadership within teams and the schools. Instructional goals will consist of comprehension and interventions.

**Next Steps:** We will be working closely with building administrators and department heads to ensure the implementation of the CC standards, as well as fidelity to the district adopted curriculum. Based on the feedback that we received regarding the PD provided, we believe that it was an effective and productive use of time and resources. In a short period of time we had seventy teachers who participated in one or more days of professional development.
