# EFB(LOCAL)

## 13 TAC 4.2(e)

1. Suggest including community members as individuals who may challenge material

(e) A reconsideration process as referenced in this section should ensure that any parent or legal guardian of a student currently enrolled in the school district or employee of the school district may request the reconsideration of a specific item in their school district's library catalog.

A District ~~resident~~ employee or a parent or guardian of a District student may ~~challenge~~ request the reconsideration of a library material maintained in the District's library program ~~on the basis that the library material fails to meet the standards set forth in this policy.~~

2. Rules require a process for how parents can gain a list of materials. So even though ours have been online for years, we have a redundancy in that the law requires us to have a process for parents to request access.
  3. Recommend not changing local to have campuses handle challenges, that is a central office function.

# CQC(LOCAL)

TECHNOLOGY RESOURCES: EQUIPMENT: This new local policy is recommended to meet the legal requirement for the board to adopt a policy for the effective integration of digital devices in the district. The policy language adopts the model health and safety guidelines developed by TEA and the Health and Human Services Commission and clarifies that the superintendent must develop regulations for implementation.
